**PROCEDURAL ORDER NO. 2**

**February 20, 2013**

Innisfil Hydro Distribution Systems Limited ("IHDSL") filed an application with the Ontario Energy Board (the "Board"), on October 24, 2012 under section 78 of the *Ontario Energy Board Act*, 1998, S.O. 1998, c. 15, (Schedule B), seeking approval for changes to the rates that IHDSL charges for electricity distribution, to be effective May 1, 2013.

The Board issued a Notice of Application and Hearing dated November 7, 2012.

In Procedural Order No. 1, issued on December 10, 2012, the Board granted the Vulnerable Energy Consumers Coalition ("VECC"), Energy Probe Research Foundation ("EP") and School Energy Coalition ("SEC") intervenor status and cost eligibility, and set dates for interrogatories and interrogatory responses.

After reviewing the responses to the interrogatories, the Board has determined that provision should be made for further written interrogatories for the purpose only of clarifying the information provided in some of the responses filed by IHDSL. The Board has also decided that it will convene a settlement conference.

The Board considers it necessary to make provision for the following matters related to this proceeding. The Board may issue further procedural orders from time to time.

**THE BOARD ORDERS THAT:**

1. Intervenors and Board staff who wish to ask questions that relate to the existing interrogatory responses filed by Innisfil Hydro Distribution Systems Limited shall file written supplemental interrogatories with the Board and deliver a copy to Innisfil Hydro Distribution Systems Limited or before **March 1, 2013**. The questions should reference the existing response and the pre-filed evidence.
2. Innisfil Hydro Distribution Systems Limited shall file with the Board complete responses to the supplemental interrogatories and deliver them to the intervenors no later than **March 15, 2013**.
3. A Settlement Conference will be convened on **March 26, 2013** starting at 9:30 a.m., in the **West Hearing Room** at 2300 Yonge Street, 25<sup>th</sup> floor, Toronto, with the objective of reaching a settlement among the parties on the issues. If necessary, the Settlement Conference will continue on **March 27, 2013**.
4. Any Settlement Proposal arising from the Settlement Conference shall be filed with the Board no later than **April 12, 2013**. In addition to outlining the terms of any settlement, the Settlement Proposal should contain a list of any unsettled issues, identifying those issues that the parties believe must be dealt with by way of oral or written hearing.
