We are writing on behalf of our client, Canadian Manufacturers & Exporters ("CME"), to seek cost award eligibility in the above-noted proceedings.

CME's request for this relief is late. We mistakenly presumed that cost eligibility for CME would continue beyond the Consultative and Working Group phase of these proceedings.

We had not realized, until today, that CME was required to request cost award eligibility. CME has been accorded cost award eligibility in each of the five (5) initiatives that form the subject matter of this Consultative. Further, no party will be prejudiced by the granting of late cost award eligibility. In these circumstances, CME should be awarded cost award eligibility for the implementation portion of the Consultative.

## Request for Cost Award Eligibility

- About 85% of CME's 1,500 Ontario-based member companies are Small to Medium sized business Enterprises ("SMEs") with 500 employees or less. The views of these businesses should be considered in this proceeding.
- 3. CME's ability to actively participate in this proceeding is dependent upon a determination that it is eligible for a Cost Award. In many prior proceedings, the Board has determined that CME is eligible for a Cost Award.
