NOTICE OF APPLICATION AND HEARING FOR AN ELECTRICITY DISTRIBUTION RATE CHANGE Sioux Lookout Hydro Inc.

Sioux Lookout Hydro Inc. ("Sioux Lookout") has applied to the Ontario Energy Board (the "Board") for permission to change its delivery charges beginning May 1, 2013. A complete application was filed on February 22, 2013 under section 78 of the *Ontario Energy Board Act*, *1998*, S.O. 1998, c.15 (Schedule B).

Delivery charges are one of four regular items on Residential and General Service customers' electricity bills and vary depending on the amount of electricity consumed. If the application is approved as submitted, the monthly bill for a Residential customer who consumes 800 kWh per month will increase by about \$8.25. The monthly bill for a General Service customer consuming 2,000 kWh per month and having a monthly demand of less than 50 kW would increase by about \$7.67. Other customers will also be affected. These proposed changes to the delivery charges are separate from other potential changes to the electricity bills, which are not affected by this application.

The Board has assigned the application File No. EB-2012-0165. This application will proceed by way of either a written or oral hearing, to be subsequently determined.

All letters of comment or letters requesting observer status will be placed on the public record, which means that the letters can be seen at the Board's office and will be available on the Board's website.
