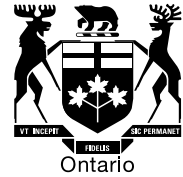

### **LETTER OF DIRECTION**

The Ontario Energy Board has now issued its Notice of Application and Hearing relating to your 2013 Lost Revenue Adjustment application (the "Notice"). Please note that you must publish the Notice within **fourteen days** of the date of this letter. If publication is not possible within fourteen days, you must inform the Board Secretary immediately.

You are directed:

1. To arrange immediately for the publication of the Notice, in the form accompanying this Letter of Direction, including all graphics and the words "Ontario Energy Board", in one issue of the English language newspaper having the highest circulation, according to the best information available, in Enersource Hydro Mississauga Inc.'s service area;
2. To arrange immediately for the enclosed French version of the Notice headed with the Ontario Government logo and the words "Commission de l'énergie de l'Ontario", to be published in one issue of the French language newspaper

having the highest circulation, according to the best information available, in Enersource Hydro Mississauga Inc.'s service area;

Please note that invoices regarding publication are not to be sent to the Board.

3. To immediately, and no later than the date of publication of the Notice, serve a copy of the Notice directly on all intervenors of record in Enersource Hydro Mississauga Inc.'s previous cost of service rate application proceeding EB-2012-0033, namely;

4. If Enersource Hydro Mississauga Inc. is a Host Distributor, to immediately, and no later than the date of publication of the Notice, serve a copy of the Notice directly on its Embedded Distributor(s);
5. To file with the Board an affidavit proving publication and service of the Notice immediately thereafter;
6. To make a copy of the application and evidence, and any amendments thereto, available for public review at Enersource Hydro Mississauga Inc.'s office and on its website;
7. To make a copy of the Notice available for public review at Enersource Hydro Mississauga Inc.'s office and on its website; and,
8. To provide a copy of the application and evidence, and any amendments thereto, to anyone requesting the material.

You are further directed not to include any document(s) or material(s) when serving the Notice other than document(s) or material(s) expressly required by this Letter of Direction to be served.
