NOTICE OF APPLICATION

ENBRIDGE GAS DISTRIBUTION INC.

**LEAVE TO CONSTRUCT NATURAL GAS DISTRIBUTION
PIPELINES AND RELATED FACILITIES IN THE
TOWNSHIP OF ALFRED AND PLANTAGENET
(INCLUDING THE FORMER VILLAGES OF ALFRED,
PLANTAGENET AND WENDOVER) AND THE TOWNSHIP
OF CHAMPLAIN (FOR THE GEOGRAPHIC AREA
KNOWN AS L'ORIGINAL) IN THE UNITED COUNTIES OF
PRESCOTT AND RUSSELL**

Enbridge Gas Distribution Inc. ("EGD") has filed an application with the Ontario Energy Board, (the "Board") dated April 10, 2008 under section 90 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c.15, Schedule B for orders granting leave to construct approximately 32 kilometres of Nominal Pipe Sizes ("NPS") 6 and 4 steel and polyethylene pipeline and a district regulating station in the subject area. The proposed pipeline is intended to supply natural gas to the said former villages and townships.

The Board has assigned File No. EB-2007-0745 to this application.

The proposed NPS 6 steel pipeline main will proceed from the Ivaco Rolling Mills located at #1040 County Road 17 in L'Original and extend westward along the north side of County Road #17 for approximately 5.3 km and then reduce to an NPS 4 steel pipe for approximately 2.6 km to a proposed district pressure regulating station along County Road #17 where the pressure will be reduced. Continuing from the district station, an NPS 6 polyethylene pipeline main will travel in a westerly direction along County Road #17 until it intersects with Dubois Street along which it will continue

approximately .5 km , then cross Blue Corners Road and travel south on the west side for 0.3 km until it again connects with County Road #17.

Continuing from the northwest corner of Blue Corners and County Road #17 the NPS 6 main will continue approximately 5 km along the north side of County Road #17 to Alfred, continuing through the village along County Road #17 until County Road #9 (also known as Old Highway 17) where the pipeline will continue southwesterly along County Road #9 into and through the Village of Plantagenet to County Road 26 where the pipeline will turn northwesterly. The pipeline will proceed along County Road 26 where its diameter will reduce to an NPS 4 polyethylene line and continue for 4.7km. A map showing the location of the proposed route is included as Appendix "A" in this Notice.

How to see the Enbridge's Application and Pre-filed Evidence

Copies of the application and the pre-filed evidence in support of the application will be available for public inspection at the Board's offices and at Enbridge Gas Distribution Inc.'s head office.

How to Participate

You may participate in this proceeding in one of three ways:

1. Send a Letter with your Comments to the Board

You may send the Board a letter of comment which will be provided to the Board members deciding the application, and will be part of the public record for the application. Your letter may include a request to make an oral presentation to the Board, and must be received by the Board no later than **30 days** from the publication or service date of this notice. The Board accepts letters of comment by either post or e-mail at the address below.

2. Become an Observer

Observers do not actively participate in the proceeding but monitor the progress of the proceeding. You may request observer status in order to receive documents issued by the Board in the proceeding. Your request must be made in writing and be received by the Board no later than **10 days** from the publication or service date of this notice. If

you become an observer, you need to contact the applicant and others in order to receive documents that they file in this proceeding and they may charge you for this. Most documents filed in this application will also be available on the Board's website. The Board accepts observer request letters by either post or e-mail at the addresses below; however, two paper copies are also required. You must also provide a copy of your letter to the applicant.

3. Become an Intervenor

You may request intervenor status if you wish to actively participate in the proceeding. Intervenors are eligible to receive evidence and other material submitted by participants in the hearing. Likewise, intervenors will be expected to send copies of any material they file to all parties to the hearing.

Your request must be made by letter of intervention and received no later than **10 days** from the publication or service date of this notice. Your letter of intervention must include a description of how you are, or may be, affected by the proceeding; and if you represent a group, a description of the group and its membership. The Board may choose to hold either a written or an oral hearing. Your letter of intervention should indicate your preference for a written or oral hearing, and the reasons for that preference. The Board may order costs in this proceeding. You must indicate in your letter of intervention whether you expect to seek costs from the applicant and the grounds for your eligibility for costs. You must provide a copy of your letter of intervention to the applicant.
