**Re: EB-2012-0040/ EB-2012-0041 Bornish Wind, LP., Kerwood Wind, Inc. and
Jericho Wind, Inc. - Application for Leave to Construct Electricity
Transmission Lines and Related Facilities**

We are counsel to the Middlesex-Lambton Wind Action Group, Inc. (“MLWAG”). As MLWAG has previously written requesting intervenor status in this matter, we are now writing to request an oral hearing on behalf of MLWAG in accordance with the Notice of Application (the “Application”) and the Ontario Energy Board's Rules of Practice and Procedure.

We note that the Ontario Energy Board has ordered that the Application proceed by way of written hearing. MLWAG believes that an oral hearing is essential for the proper determination of the complex nature of the contested issues in this Application. As a result, MLWAG wishes to have the option of raising those contested issues, of presenting its position and seeking clarification through cross-examination at an oral hearing

regarding, but not limited to, the easements required from landowners along the proposed route of the transmission line, the land acquisition agreement that forms part of this Application, the potential impact on residences along the proposed route of the transmission line including those not subject to easements, the proximity of the substation to residential dwellings and the accuracy of the location of the 115 Kv power line as depicted in the Application.

MLWAG intends to seek an award of costs for the reasons discussed above.
