**PROCEDURAL ORDER NO. 4**  
**April 5, 2013**

K2 Wind Ontario Limited Partnership (“K2 Wind”) filed an application with the Board dated December 5, 2012 under sections 92 and 97 of the *Ontario Energy Board Act, 1998* (the “Act”). K2 Wind has applied for an order of the Board for leave to construct approximately 5.1 km of underground single circuit 230 kilovolt (“kV”) electricity transmission line and associated facilities (the “Proposal”), and for an order approving the form of agreements that have been or will be offered to landowners affected by the Proposal. The Board has assigned File No. EB-2012-0458 to this application.

By way of Procedural Order No. 3 the Board set out the schedule for two motions filed with the Board. The first is a motion filed by the Residents Group requesting that the Board order K2 Wind to answer more fully a number of the interrogatories they submitted on March 4, 2013. The second is a Notice of Motion filed by K2 Wind on April 1, 2013 seeking an Order of the Board striking out the three affidavits filed on behalf of the Residents Group. The Board determined that it would hear both motions in writing.

On April 4, 2013 the Board received a letter from K2 Wind requesting an opportunity to file an argument in chief in support of its Motion. The Board notes that in the future, it

would be more procedurally efficient for parties, when filing a motion, to include their argument in chief along with any other supporting material concurrently.

The dates set out in Procedural Order No. 3 are hereby rescinded and replaced by the following.

**THE BOARD ORDERS THAT:**

1. K2 Wind and the Residents Group shall file with the Board and deliver to all parties any submissions they wish to make in support of their respective Motions on or before **April 8, 2013**.
2. K2 Wind shall file with the Board and deliver to all parties any submission it wishes to make in response to the Motion for further answers to interrogatories on or before **April 15, 2013**.
3. The Residents Group shall file any reply submission with the Board and deliver it to all parties by **April 22, 2013**.
4. If the Residents Group, any other intervenor or Board staff wishes to make a submission on the motion for an order striking out the affidavits filed by the Residents Group, such submissions shall be filed with the Board and delivered to all other parties, by **April 15, 2013**.
5. K2 Wind shall file any reply submission with the Board and deliver it to all parties by **April 22, 2013**.

All filings to the Board must quote file number EB-2012-0458, be made through the Board's web portal at <https://www.pes.ontarioenergyboard.ca/eservice/>, and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties shall use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at [www.ontarioenergyboard.ca](http://www.ontarioenergyboard.ca).

If the web portal is not available, parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
