- 3. Enbridge has a direct interest in all matters of jurisdiction, substance, and procedure in the regulation of public utilities, and in any decision of the Ontario Energy Board (the "Board"), which may create a precedent for, or otherwise affect, the Company's own applications.
- 4. Enbridge purchases certain storage and transportation services from Union Gas Limited ("Union") pursuant to rate schedules approved by the Board.

- 5. Enbridge reserves the right to be heard in English, to appear by or with counsel of its choice, to cross-examine on all subject matters in this hearing that may relate to its interests, to adduce evidence on specific matters that are relevant to these proceedings, and to present argument.
