IN THE MATTER OF the Municipal Franchises Act, R.S.O. 1990 c. M.55, as amended:

AND IN THE MATTER OF an Application by Union Gas Limited for an Order approving the terms and conditions upon which, and the period for which the Corporation of the Township of South-West Oxford is, by by-law, to grant to Union Gas Limited the right to construct and operate works for the distribution, transmission and storage of natural gas and the right to extend and add to the works in the Township of South-West Oxford;

AND IN THE MATTER OF an Application by Union Gas Limited for an Order directing and declaring that the assent of the municipal electors of the Township of South-West Oxford to the by-law is not necessary;

The Ontario Energy Board has issued its Decision and Order dated April 11, 2013, which approves the above-noted Franchise Agreement and the Certificate of Public Convenience and Necessity. Union now serves upon you a copy of the Decision and Order.

The attached Certificate of Public Convenience and Necessity (EB-2013-0021) for the amalgamated Corporation of the Township of South-West Oxford replaces the Certificates that had been in place for the former municipalities incorporated into the Township of South-West Oxford except for those areas covered by the Certificate of Public Convenience and Necessity E.B.C. 111 and 119 held by Natural Resource Gas Limited (a copy of E.B.C. 111 and 119 is attached).

Union has the four (4) signed copies of the Franchise Agreement sent by your letter dated April 4, 2013. We also received four (4) copies of the By-law to authorize the Franchise Agreement, which appears to have been given third and final reading by your Council. There is an error in the By-law, whereby the date of the Board's Decision is shown as December 4, 2012. It should read April 11, 2013. Please correct this date and return all four (4) copies of the By-law to my attention.

We await the corrected copies of the By-law from you before we execute the Franchise Agreement. Upon receipt of the above, Union Gas will execute the Franchise Agreement and return one (1) executed copy of the Franchise Agreement and corresponding By-law to your attention.

THE CORPORATION OF THE TOWNSHIP OF SOUTH-WEST OXFORD BY-LAW NUMBER 97-2012

A BY-LAW TO AUTHORIZE A FRANCHISE AGREEMENT BETWEEN

THE CORPORATION OF THE TOWNSHIP OF SOUTH-WEST OXFORD and UNION GAS LIMITED

WHEREAS the Council of the Corporation of the Township of South-West Oxford deems it expedient to enter into the attached franchise agreement (the "Franchise Agreement") with Union Gas Limited;

AND WHEREAS the Ontario Energy Board by its Order issued pursuant to The Municipal Franchises Act on the 4th day of December, 2012 has approved the terms and conditions upon which and the period for which the franchise provided in the Franchise Agreement is proposed to be granted, and has declared and directed that the assent of the municipal electors in respect of this By-Law is not necessary:

NOW THEREFORE the Council of the Corporation of the Township of South-West Oxford enacts as follows:

- 1. **THAT** the Franchise Agreement between the Corporation of the Township of South-West Oxford and Union Gas Limited attached hereto and forming part of this by-law, is hereby authorized and the franchise provided for therein is hereby granted.
- 2. **THAT** the Mayor and CAO be and they are hereby authorized and instructed on behalf of the Corporation of the Township of South-West Oxford to enter into and execute under its corporate seal and deliver the Franchise Agreement, which is hereby incorporated into and forming part of this By-Law.
- 3. THAT the following by-law be and the same is hereby repealed:

By-law #36-91 for the Corporation of the Township of South-West Oxford, passed in Council on the 15th day of June, 1993;

4. THAT this by-law shall come into force and take effect as of the final passing thereof.

Read a first and second time this 4th day of December, 2012.
