



Chase’s dream still going

(STAFF) — The Heart and Stroke Foundation (HSF) hosts the sixth annual Chase McEachern Memorial Hockey Tournament, Saturday at East Bayfield Community Centre.

Money raised at the tournament will go directly to the Chase McEachern Tribute Fund and will help install automated external defibrillators (AEDs) in public places in Simcoe County.

To date, the fundraiser has collected more than \$280,000.

At age 11, Chase was not only a left winger, but he also became an alternate captain for the Vaughan Kings minor peeew 'AAA' team in the Greater Toronto Hockey League.

In October, 2005, after being injured playing a pick-up football game at school, he went to the emergency room where the doctors happened to discover his heart was beating fast — up to 150 times a minute — even though he was sitting in bed, a condition later diagnosed as an atrial flutter.

That night, he went by air ambulance to Sick Children's Hospital in Toronto and the next day underwent a cardiovert, in which doctors returned his heart rhythm back to normal with a small electric pulse while Chase was under a general anesthetic.

The procedure was successful and Chase went back to school and continued playing hockey, but this time, under doctors' orders, wearing a heart monitor. During practice, however, Chase's heart would sometimes beat up to 320 times a minute.


After hearing that professional hockey player Jiri Fischer had collapsed and Mario Lemieux retired because of irregular heartbeats like his, Chase decided to start a campaign to make AEDs mandatory in hockey arenas and schools everywhere.

"He realized that heart problems didn't just affect older people," said his mother, Dorothy.

Chase also wrote a letter to hockey commentator Don Cherry, asking for his support.

But before the campaign launched, Chase collapsed while at school and died before his dream could become a reality.

This weekend's event will include an announcement involving the top 15 fundraisers at noon on Saturday, followed by a two-period game at 7 p.m.

PowerStream Inc. ("PowerStream") filed an application with the Ontario Energy Board (the "Board"), dated March 13, 2013 seeking Board approval for a conservation and demand management ("CDM") program – Direct Install Refrigeration Program.

The Board has assigned file number EB-2013-0070 to this application.

The application has been filed pursuant to the Board's CDM Code that was issued on September 16, 2010. The CDM Code was developed by the Board in response to a Directive from the Minister of Energy dated March 31, 2010.

The program for which PowerStream is seeking approval is the Direct Install Refrigeration (DIR) program to partially address its projected shortfall against its 2011-2014 CDM targets. The DIR program is projected to cost \$4.1Million and generate 3.3MW and 19.6 GWh of net savings, representing an additional 3.5% and 4.8% towards PowerStream's 2011-2014 demand and energy targets, respectively. The DIR program addresses market-specific needs of small commercial customers, a market segment that PowerStream claims is underserved by the Electricity Retrofit Incentive Initiative within the Provincial Commercial & Industrial Program.

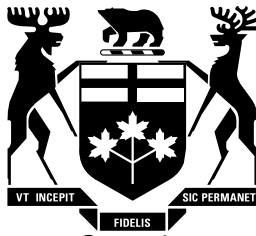

PowerStream Inc. (« PowerStream ») a déposé une requête auprès de la Commission de l'énergie de l'Ontario (la « Commission ») en date du 13 mars 2013, en vue d'obtenir l'approbation par la Commission d'un programme de gestion de la demande et de conservation (« GDC ») – programme Direct Install Refrigeration.

La Commission a assigné à cette requête le numéro de dossier EB-2013-0070.

La requête a été déposée conformément au Code de GDC de la Commission, publié le 16 septembre 2010. Le Code de GDC a été élaboré par la Commission en réponse à une directive du ministre de l'énergie en date du 31 mars 2010.

Le programme pour lequel PowerStream demande l'approbation est le programme Direct Install Refrigeration (DIR) pour répondre partiellement à son déficit projeté par rapport à ses objectifs de 2011-2014 au titre de la GDC. Il est prévu que le programme DIR coûte 4,1 million de dollars et génère 3,3 MW et 19,6 GWh d'économie nette, ce qui représente 3,5% et 4,8% de plus que les objectifs de PowerStream concernant la demande en énergie de 2011 à 2014, respectivement. Le programme DIR répond aux besoins particuliers des marchés de petits clients commerciaux, un segment de marché qui prétend que PowerStream est mal desservi par le Programme d'incitation à l'amélioration énergétique au sein du Programme commercial & industriel provincial.
