We hereby respectfully requests that you accept this letter as our written request to amend Section 3.1 of the above noted Gas Marketers Licence to read as follows:

Section 3.1

The Licensee is authorized, under Part IV of the Act, and subject to the terms and conditions set out in this Licence:

- a) to act or offer to act as the agent or broker of a low-volume consumer in the purchase of gas.

The nature of EnerStream's business is more accurately reflected by this amendment, given that EnerStream only ever acts as an agent on behalf of its customers.

EnerStream respectfully requests that this proceeding be disposed of without a hearing pursuant to Section 21(4)(b) of the *Ontario Energy Board Act, 1998*. EnerStream consents to disposing of this proceeding without a hearing and confirms that no person will be adversely affected in any material way by the outcome of the proceedings.
