Schneider Power Inc. currently holds a generation licence to own and operate the Providence Bay Wind Farm in Manitoulin.

Schneider Power Inc. has applied for an amendment to Schedule 1 of its generation licence to include four new wind farms: Arthur Wind Farm, Trout Creek Wind Farm, Innisfil Wind Farm, and Spring Bay Wind Farm.

The application indicates that Schneider Power Inc. directly owns Spring Bay Wind Farm whereas the other three wind farms are owner by other companies.

Section 57(c) of the *Ontario Energy Board Act, 1998* states that a person must be licenced to generate electricity. Therefore, if a person, which includes a corporation, is going to own or operate a generation facility, that person must be licensed by the Board.

Since Arthur Wind Power Inc., Trout Creek Wind Farm Inc., and Innisfil Wind Power Inc. own the Arthur Wind Farm, Trout Creek Wind Farm, and Innisfil Wind Farm respectively, the corporations must apply for generation licences for their respective facilities.

In relation to Schneider Power Inc.'s application to amend Schedule 1 of its generation licence to add the Spring Bay Wind Farm, the following additional information is required:

- 1. a brief summary of Schneider Power Inc.'s business plan for the new wind farms, and a current corporate organization chart showing the applicant and affiliated companies;
- 2. a draft revised Schedule 1 for Schneider Power Inc., including municipal addresses for each facility that Schneider Power Inc. will own or operate. Please indicate which facilities will be owned directly by Schneider Power Inc., and which ones will be operated by Schneider Power Inc.;
- 3. the capital cost of any project that Schneider Power Inc. will own or operate; and
- 4. a brief description of financing arrangements.
