On April 2, 2013, Union Gas Limited ("Union") filed an application with the Ontario Energy Board under the *Municipal Franchises Act*, R.S.O. 1990, c. M55, for an order approving the terms and conditions upon which, and the period for which, the Corporation of the Township of Wellesley is, by by-law, to grant to Union the right to operate works and add to works for the distribution of gas in the Township of Wellesley for a period of 20 years, and for an order declaring and directing that the assent of the municipal electors is not necessary. The application has been assigned Board file number EB-2013-0095.

The application will be decided by the Manager, Natural Gas Applications, who has been delegated this authority pursuant to section 6 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c.15 (Schedule B). The Manager, Natural Gas Applications does not intend to provide for an award of costs when deciding the application.
