Part A - Regulated prices if you purchase your natural gas from Enbridge Gas Distribution Inc.

If you purchase your natural gas from Enbridge Gas Distribution Inc., your natural gas prices are set by the Ontario Energy Board, the independent regulator, and can change every three months (January 1st, April 1st, July 1st and October 1st). The table below shows the natural gas prices that are in effect today. The "Estimated Monthly Gas Supply & Transportation Cost" shown is for the **cost of the natural gas** that you use and for **related transportation costs**. Part B below will show you whether transportation costs are included in the contract you are being offered or whether you would continue to pay the utility price. You will also have to pay **customer charges and charges for delivery (including storage) to your utility** every month, as well as any taxes payable on your total monthly bill. This table is based on a **residential consumer who uses 3,064 m³ per year**. It assumes that usage is the same every month. However, the amount of natural gas you actually use in each month changes throughout the year. If your actual monthly natural gas use is different, your "Estimated Monthly Gas Supply & Transportation Cost" will also be different.
