We have been asked by the Wikwemikong Unceded Indian Reserve to assist them in connection with the preparation of written submissions as ordered by the Board on April 26, 2013.

McLean's Mountain Wind Limited Partnership (McLean's) filed an application with the Board dated January 17, 2013 under section 60 of the *Ontario Energy Board Act, 1998*, seeking an Electricity Generation License as a Feed-In-Tariff Program Participant. On February 26, 2013 the Wikwemikong Unceded Indian Reserve No.26 filed a request with the Board for an Oral Hearing. The Board ordered that if Wikwemikong wished to make a submission in accordance with the scope of the proceeding, it shall do so by filing its submission with the Board in writing and serving it on all other parties by May 3, 2013.
