PROCEDURAL ORDER No. 5

May 6, 2013

On December 23, 2010, Hydro One Remote Communities Inc. ("Remotes") filed an application with the Ontario Energy Board (the "Board") (updated March 1, 2011) for a licence amendment under section 74 of the *Ontario Energy Board Act, 1998* seeking exemptions from the following sections of the *Distribution System Code*: 2.7.1.2; 2.7.1.3; 2.7.2; 2.8.1; 2.8.2; 4.2.2.3; 4.2.3.1(a); 6.1.2.1; 6.1.2.2 and 7.10.

On March 21, 2011, the Board issued a Notice of Application and Written Hearing for the application and granted a request for intervention and cost eligibility from Nishnawbe Aski Nation ("NAN").

On April 25, 2013, the Board issued its Decision and Order in which it set out the process for NAN to file its cost claim. In a letter filed with the Board on May 6, 2013, NAN requested an extension to the deadline for filing its cost claim from May 9, 2013 to May 20, 2013. The Board will grant an extension to May 21, 2013, given that May 20, 2013 is a statutory holiday.

The Board finds it necessary to make provision for the following matters related to this proceeding.

THE BOARD ORDERS THAT:

1. NAN shall file with the Board and forward to Remotes its cost claim by May 21, 2013.
2. Remotes shall file with the Board and forward to NAN any objections to the claimed costs by May 28, 2013.
3. NAN shall file with the Board and forward to Remotes any response to any objections to its cost claim by June 4, 2013.

All filings to the Board must quote the file number, EB-2011-0021, consist of two paper copies and one electronic copy in searchable / unrestricted PDF format, made through the Board's web portal at www.pes.ontarioenergyboard.ca/eservice. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Please use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at www.ontarioenergyboard.ca. If the web portal is not available you may email your document to the address below.
