PROCEDURAL ORDER No.2

Guelph Hydro Electric Systems Inc. filed an application with the Ontario Energy Board (the "Board"), received on February 26, 2008 under section 78 of the *Ontario Energy Board Act*, 1998, seeking approval for changes to the rates that Guelph Hydro Electric Systems Inc. charges for electricity distribution, to be effective May 1, 2008. The Board has assigned the application file number EB-2007-0742. The Board issued a Notice of Application and Hearing dated January 9, 2008.

The Board issued Procedural Order No. 1 on April 14, 2008, which established a schedule for the filing of interrogatories, responses to interrogatories, submissions by Board staff and intervenors and any reply submissions by Guelph Hydro Electric Systems Inc.

On May 8, 2008 Guelph Hydro Electric Systems Inc. requested an extension to the filing date for interrogatory responses and proposed a new date for filing of interrogatories, responses to interrogatories. While the Board provides extensions to these dates as noted below, the Board is concerned about the extension of deadlines in light of the fact that the application was filed well past the date the Board had set for filing 2008 cost of service applications. The Board had set a deadline of August 15, 2007 to ensure new rate orders by May 1, 2008.

THE BOARD ORDERS THAT:

1. The applicant shall file with the Board complete responses to the interrogatories and deliver them to the intervenors no later than Friday May 23, 2008.
2. Intervenors or Board staff who wish to make a submission on the application must file that submission with the Board, and deliver it to the applicant and other intervenors by Friday June 13, 2008.
3. If the applicant wishes to respond to a submission, the response must be filed with the Board and delivered to intervenors by Friday June 20, 2008.

All filings to the Board must quote file number EB-2007-0742, be made through the Board's web portal at www.errr.oeb.gov.on.ca, and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Please use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at www.oeb.gov.on.ca. If the web portal is not available you may email your document to the address below. Those who do not have internet access are required to submit all filings on a CD or diskette in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.

All communications should be directed to the attention of the Board Secretary at the address below, and be received no later than 4:45 p.m. on the required date.
