**AND IN THE MATTER OF** an application by Chatham Resources Ltd. and Bayview Exploration Ltd. for an order of the Ontario Energy Board, pursuant to section 43 of the *Ontario Energy Board Act*, 1998, approving the disposition of Bayview Exploration Ltd.'s natural gas distribution system assets located in the County of Norfolk to Chatham Resources Ltd or its nominee;

### **NOTICE OF APPLICATION AND WRITTEN HEARING**

An application (the "Application"), received March 6, 2008, has been filed with the Ontario Energy Board (the "Board") by Chatham Resources Ltd. ("Chatham") and Bayview Exploration Ltd. ("Bayview") for an order of the Board, pursuant to section 43 of the Ontario Energy Board Act, 1998, S.O. 1998, c.15, Sched. B (the "Act"), seeking approval for the disposition of the natural gas distribution system assets of Bayview, located in the County of Norfolk, to Chatham or to such other nominee of Chatham.

The Board has assigned Board File No. EB-2008-0057 to the application.

Bayview owns and operates a small natural gas distribution system and gas wells in the County of Norfolk near Simcoe. Chatham also owns and operates natural gas wells and small gas distribution systems in this area. Bayview proposes to sell its natural gas distribution system and other assets to Chatham or Chatham's nominee.

The Board intends to proceed with the application by way of a written hearing unless a party satisfies the Board that there is a good reason for not holding a written hearing. If you object to the Board holding a written hearing in this matter, you must provide written reasons why an oral hearing is necessary. Any submissions objecting to a written hearing must be received by the Board within 7 days of the publication date of this Notice.

If you wish to participate in the written hearing, you must forward three copies of your written submissions to the Assistant Secretary of the Board and one copy to the applicant at the addresses below. All submissions must be received no later than 14 days after the publication date of this Notice. If the Applicant wishes to respond to the written submissions, such response must be received by the Board no later than 21 days after the publication date of this Notice. All submissions must quote Board File Number EB-2008-0057, clearly state the sender's name and address, and be received by the Board Secretary by 4:45 p.m. on the required dates.

**IF YOU DO NOT FILE A WRITTEN SUBMISSION OBJECTING TO A WRITTEN HEARING OR DO NOT PARTICIPATE IN THE HEARING BY FILING WRITTEN SUBMISSIONS IN ACCORDANCE WITH THIS NOTICE, THE BOARD MAY PROCEED WITHOUT YOUR PARTICIPATION AND YOU WILL NOT BE ENTITLED TO FURTHER NOTICE IN THIS PROCEEDING.**
