**Re: McLean's Mountain Wind Limited Partnership
Application for Feed-in-Tariff Program Electricity Generation Licence
Board File No. EB-2013-0015**

We are counsel to McLean's Mountain Wind Limited Partnership ("McLean"), the Applicant in the above captioned matter.

On April 26, 2013, the Board issued its Decision on Oral Hearing and Procedural Order No. 1 (referred to here as "PO#1"). In PO#1, the Board denied the request of Wikwemikong Unceded Indian Reserve No. 26 (referred to here as "Wikwemikong") for an oral hearing, and allowed Wikwemikong until May 3, 2013 to deliver its submission, if any, in accordance with the scope of the proceeding. McLean was allowed until today to file its reply submission, if any.

It appears that during the afternoon of Friday, May 3, 2013, counsel to Wikwemikong faxed to the Board a letter requesting an extension of the filing deadline to Monday, May 6th. Neither we nor McLean received a copy of that letter. Late in the afternoon of Tuesday, May 7, 2013, counsel to Wikwemikong apparently faxed a submission to the Board, with a copy to our client. We were not copied on either of those letters, and we would appreciate it if Wikwemikong's counsel would include us in any future correspondence. My direct fax line and email address are shown in the upper left hand corner of this letter.

McLean intends to respond to the May 7th Wikwemikong letter, and to submissions of other persons who have filed letters in this proceeding to the extent that those submissions may be within the scope of this proceeding. In light of the timing of the Wikwemikong filing, McLean will require a brief amount of additional time to file its reply. We anticipate that McLean's reply submission will be delivered by Tuesday, May 14, 2013.

We trust that this will be satisfactory to the Board, and we thank you in advance for your consideration in this matter. Should you have any questions or require further information in this regard, please do not hesitate to contact me.
