**Re: Oakville Hydro Energy Services Inc.  
Licence Amendment – EG-2004-0415**

On April 26, 2013 Oakville Hydro Energy Services Inc. (“OHESI”) submitted a notice of its proposal under Section 80 of the *Ontario Energy Board Act* to acquire the Kagawong Generating Station and in relation to two solar rooftop projects. On May 14, 2013, the Ontario Energy Board (the “Board”) acknowledged receipt of the proposal and assigned file number EB-2013-0194.

In the Notice, OHESI advised the Board that it would file a request for an amendment to its Electricity Generation licence to add the Kagawong Generating Station to Schedule One of its licence. At the same time, Kagawong Power Incorporated requires an amendment to its Electricity Generating licence to remove the Kagawong Generating Station from Schedule One of its licence.

In an effort to facilitate the processing of these amendments, OHESI hereby submits a request to amend its Electricity Generation licence along with a request from Kagawong Power Incorporated for an amendment to its Electricity Generation licence.

Licence Amendment – EG-2004-0415**

Oakville Hydro Energy Services Inc. ("OHESI") is licensed to generate electricity in the province of Ontario under Electricity Generating Licence EG-2004-0415. Under the terms and conditions of its generating licence, OHESI is permitted to generate electricity at its Halton Regional Waste Management Facility located at 5400 Regional Road 25 in the Town of Milton, Ontario.

OHESI is now seeking an amendment to Schedule 1 of its Electricity Generation Licence to include the Kagawong Generating Station located on the Kagawong River on Manitoulin Island in the Province of Ontario. The Kagawong Generating Station is a 0.75 MW single-unit, run-of-river hydroelectric project which will be owned and operated by the Licensee. It is located in the Village of Kagawong on Manitoulin Island and operates on the Kagawong River near the mouth of Lake Kagawong. The project operates under various regulatory agreements including an Ontario Power Authority ("OPA") sponsored, 20-year Hydro Contract Initiative ("HCI") power purchase agreement awarded in 2010.

OHESI is also requesting an amendment to include its two existing solar facilities located at Oakville Hydro Electricity Distribution Inc.'s corporate office at 861 Redwood Square and Oakville Town Hall at 1225 Trafalgar Road in the Town of Oakville on Schedule 1 of its Electricity Generation licence. Both facilities are owned and operated by the licensee.

OHESI requests that the Board dispose of this proceeding without a hearing, pursuant to section 21(4) (b) of the *Ontario Energy Board Act, 1998*. OHESI submits that no other person will be affected in a material way by the outcome of this proceeding and consents to the disposition of this proceeding without a hearing.

OHESI submits that its anticipated MWh production as a percentage of the Annual Primary Demand, within the Province of Ontario after the acquisition of the Kagawong Generating Station will be immaterial and that there will be no impact on competition or customer choice with respect to generation, energy wholesalers and/or energy retailers as the generating facility is subject to a contract with the OPA. OHESI also submits that that there will be no impact on open access to the transmission or distribution system as the Kagawong Generating Station is already connected to the Hydro One distribution system.

Kagawong Power Inc. ("KPI") is licensed to generate electricity in the province of Ontario under Electricity Generation Licence EG-2003-0139. Under the terms and conditions of its generation licence, KPI is permitted to generate electricity at its Kagawong Generating Station in Kagawong, Ontario and its Charlton Dam Generating Station in Charlton, Ontario. KPI hereby requests that Schedule 1 of its Electricity Generation Licence, EG-2003-0139, be amended to remove the Kagawong Generating Station from the list of licenced generation facilities as of May 15<sup>th</sup>, 2013.


The Kagawong Generating Station is a 0.75 MW hydroelectric generating facility located in the Village of Kagawong on Manitoulin Island. Oakville Hydro Energy Services Inc. ("OHESI") will acquire the Kagawong Generating Station from KPI in March 2013 and become the owner and operator of the facility. OHESI is licensed to generate electricity in the province of Ontario under Electricity Generation Licence EG-2004-0415.

KPI requests that the Board dispose of this proceeding without a hearing, pursuant to section 21(4)(b) of the *Ontario Energy Board Act, 1998*. KPI submits that no other person will be affected in a material way by the outcome of this proceeding and consents to the disposition of this proceeding without a hearing.

KPI also submits there will be no impact on competition or customer choice with respect to generation, energy wholesalers and/or energy retailers as the Kagawong

Generating Station is an existing facility and that there will be no impact on open access to the transmission or distribution system as the Kagawong Generating Station is already connected to the Hydro One distribution system.
