The Board has reviewed your application for a Feed-in Tariff Program electricity generation licence. Your application is currently incomplete and cannot be processed until the following has been filed:

1. Section 2, Pages 2 of the Application Form – Feed-in Tariff Program Contract and Notice to Proceed:

Section 2 of the application requires to provide details regarding the FIT contract with the OPA and Notice to Proceed ("NTP"). Information provided in this section does not match the information included in the attached NTP, specifically

- FIT reference No in the application form is F38LD1U while FIT contract No in the NTP is F-000670-SVP-130-505:
- In the application form the date the NTP was received shows February 15, 2013, while the attached NTP shows March 14, 2013 as the issuance date.

Please make applicable changes in section 2 and resubmit page 2 of the application form.

2. Section 7, Pages 4 of the Application Form – Generation Facilities:

Section 7 a) of the application requires to provide the address of the facility. The address provided appears to be **not** a full address of the facility as it contains only Lot and Concession numbers.

Please provide full address of the facility which includes township, county, region, etc. and resubmit page 4 of the application form.

3. Section 10, Pages 6 of the Application Form – Licensing History:

Section 10 a) of the application requires to answer a question whether the applicant has ever been licensed by the Board. You have answered "Yes" and provided the licensee No EG-2012-0393, however the name of the licensee appears to be different from the applicant's name.

Please explain whether 2176050 Ontario Inc. has changed its name to the applicant's name since the licence EG-2012-0393 has been issued. If yes, a licence amendment may be required instead of a new licence application. If the applicant is a separate legal entity from 2176050 Ontario Inc., the answer to question 10 a) should be "No", the information about the licensee should be removed and page 6 resubmitted.

The Board will resume processing your application once the above information has been filed. If the above information is not filed within 30 days of the date of this letter, the Board may close the file for this application.

Upon receipt of the required information the Board will issue an acknowledgement letter indicating the expected date on which a decision and/or order may be rendered.
