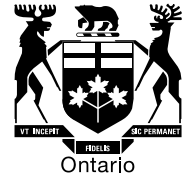

**Re: Application for Gas Marketer Licence and  
Application for Electricity Retailer Licence  
Board File Numbers EB-2013-0076 and EB-2013-0077**

The Board has reviewed your applications for a gas marketer licence and an electricity retailer licence. On April 12, 2013, the Board issued a letter stating that your applications are incomplete and setting out the information required for the applications to be processed.

Board Staff have also sent emails on April 29, 2013, May 21, 2013 and May 27, 2013 inquiring on when we can expect to receive the requested information. On May 28, 2013 some of the information requested was provided. However, your applications are still currently incomplete and cannot be processed until the following has been filed:

**Required for EB-2013-0076 and EB-2013-0077:**

1. Section 15- Documents to support identity:

The copies of the passport identification provided for Ms. Singh and Mr. Vernon are **not** acceptable as the images of the individuals are not clear. Would you please provide clear copies of these documents.

2. Section 12 – Please provide the following:

- a) Financial statements, including profit and loss statements, balance sheets, and cash flow statements from 2008-2012. These must be signed by one key individual; and

- b) Letter of reference from the bank setting out the information as required in section 12 of the application form.
3. The form entitled "Release and Discharge Relating to Consent to Disclosure of Criminal Record Information" needs to be completed for yourself, Mr. Krawetz, as you are named as a key individual. This form was sent to you along with the letter of April 12, 2013.

**Required for EB-2013-0077:**

4. Section 11(b) of the form is incomplete – please provide a description of the current business activities.

The Board will resume processing your applications once the above information has been filed. If the above information is not filed by **June 21, 2013**, the Board may close the files for these applications. Please note that your interim gas marketer and electricity retailer licences are due to expire on July 27, 2013.
