

Haisla take step in bid to cross Pacific

Two international partners, including Bermuda-based Golar, help backstop \$500-million project that would sell LNG to Asia

A small B.C. natural gas export project has moved closer to selling Canadian energy to Asia after a pair of international investors agreed to help backstop the \$500-million project.

Bermuda-based Golar LNG Ltd. had already committed some of its liquefied natural gas vessels to BC LNG, the pint-sized export facility backed in part by the Haisla First Nation near Kitimat, B.C. Now Golar, alongside an unnamed Asian firm, has agreed to partner in the project, with Golar taking a 25-per-cent ownership stake in a facility that stands to be the first in Canada to send natural gas across the Pacific.

The partners have also agreed to assist with financing for the Haisla, who hold a 20.5-per-cent stake in the bid to export 600,000 to 700,000 tonnes a year of LNG.

Financing is "the biggest question you have on whether a project is going to go ahead," Haisla chief councillor Ellis Ross said Thursday. The new partnerships mean "that one of the biggest hurdles of the project to go ahead is just about complete."

The project is not yet ready to build. Final engineering is required to put down an accurate pricing, an important consideration. Although the major act authorizations are in place, smaller construction permits must still be secured from federal and provincial authorities.

The Haisla are confident enough in the project, however, that they anticipate committing to pipeline space by the end of July, with an expected 20-year agreement worth some \$2-billion.

A final investment decision could come by the third quarter. Overseas construction of liquefaction equipment, which will be floated into place by barge, could begin this winter, with the Haisla predicting first gas shipments in 2016.

The BC LNG project is small relative to the giant projects envisioned by companies such as Royal Dutch Shell PLC, which's planning to move 12 million

tonnes a year.

Yet for British Columbia, the possibility of a start to an LNG project, no matter the size, drew a sharp response. Rich Coleman, the provincial energy minister, was quick to take credit for what he said will be "billions" of dollars in coming commitments.

"You'll see over the next number of months that there were a lot of investments sitting on the sidelines waiting for the outcome of our election," he said. "I think [the Haisla deal] is probably an early indicator."

The Haisla say the new partners are primarily motivated by the compelling economics of selling B.C. natural gas, although the recent re-election of the provincial Liberal government "gave everyone a bit of comfort."

Many observers, however, remain skeptical that many of the

half-dozen proposed West Coast LNG operations will be built, given the tremendous cost overruns that have afflicted such projects in places like Australia. Global competition for LNG sales is also strong, and overseas buyers have sought to depress the high international prices that have stoked so much interest in getting gas out of North America, where prices have been low.

BC LNG has deals in place to sell all of its projected output, but those deals use North American prices as a basis, rather than the higher oil-indexed prices. An inability to sign lucrative deals has hampered others in the LNG race, including Chevron Corp.-backed Kitimat LNG, a project that has already spent hundreds of millions to prepare a site on Douglas Channel, but has struggled with sales agreements.

BC LNG is a very different project, however, relying on existing technologies that can be built offshore and then sailed to British Columbia. It will also use an existing pipeline.

"It's a shrewd opportunistic approach," said Jihad Traya, associate director North American natural gas with global consulting firm HIS. "They can take advantage of a small opportunity. And mark my words, we'll see a little bit more on the LPG side like this." LPG, or liquefied petroleum gas, is a liquid natural gas by-product whose price in Western Canada has been severely depressed. For exporters, its advantage is that it can be shipped to the West Coast by train and rail lines that already exist.

Why not upgrade? Gift cards arrive at Air Canada

Air Canada is introducing new gift cards as impulse buying creeps further and further into air travel.

The cards can be purchased online from Air Canada, as electronic or regular plastic cards. In amounts from \$25 to \$500. They can be redeemed toward the purchase of tickets or options such as advanced seat selection when reserving a ticket online. By the end of June, the cards will

be good for making purchases at Air Canada airport check-in counters.

Air Canada said Thursday that it is the first Canadian airline to offer a gift card which doesn't expire and is transferable. Porter Airlines sells gift certificates too which are transferable, although some of the fine print about how they can be used may be different.

WestJet Airlines Ltd. used to sell gift certificates until it changed its reservation system in 2009, but it said Thursday it hopes to

sell them again "in the next two or three years."

Air Canada's vice-president of marketing, Chris Landry, said the idea came from staff and customers asking about gift cards. Many of the comments landed in the airline's house, electronic suggestion box dubbed "Creative Juice."

"Sometimes simple ideas are pretty simple. The truth is, the gift card is really about giving customers what they want," Mr. Landry said.

The cards are arriving as air

travellers are increasingly confronted with numerous options to upgrade, for different bundles of services or for individual perks. These perks, such as reserved seating or admission to special waiting lounges, are strategically offered when completing an online reservation or checking in at the gate.

"There's flagging it like crazy everywhere you go. At the gate, before you push the button [online], you always look at what the option is to have a better seat," said Suzanne Christie, pres-

ident of the online travel-industry journal Open Jaw Network. Mr. Landry said the cards are not geared toward impulse buying, but are a response to something requested from customers over the years.

Still, by selling gift cards, Air Canada is getting money ahead of the time of the purchase, "which is kind of a nice thing to have when you're in business," Ms. Christie noted.

BANKS from BI

Canada's six big banks (Royal Bank of Canada, Scotiabank, TD Bank, Bank of Montreal, Canadian Imperial Bank of Commerce and National Bank) earned roughly \$7.5 billion during the second quarter this year. That's up from \$7.1 billion for the April to June period in 2012.

However, Scotiabank, TD Bank, the Bank of Montreal and Royal Bank all missed Bay Street expectations, "making the tally four misses out of six this quarter, ending the streak of largely positive earnings releases for the Canadian banks," noted Barclays Capital analyst John Aiken in a research report Thursday.

Canadian banks are bracing for a squeeze on several fronts: the persistence of record-low interest rates means slim profit margins; a slower housing market means a slowdown in mortgage lending; and the economy is likely to be only lukewarm this year, growing at about 1.5 per cent and keeping a lid on the job market. That will make consumers hesitant to borrow.

"The Canadian banks are very well-run institutions. Given their strong capital levels and their history of strong returns, I'm confident they will continue to find profitable growth opportunities," said David Tuttle, research analyst at Templeton Global Equity Group.

"But in the context of the slowing

Canadian retail customer, it may be more difficult going forward."

TD Bank chief executive officer Ed Clark warned analysts this week that "The fundamentals of our businesses are strong, but we continue to face headwinds from slower loan growth in Canada and low interest rates globally."

TD, which has more branches in the U.S. than in Canada, will benefit from its diverse geography, analysts say. Likewise, Scotiabank will be helped by its extensive business lines in Latin America and South America.

Capital markets, which include lending to large corporations, advisory work on mergers and acquisitions, and equity and bond under-

writing, are also likely to become a key focus, analysts say. Royal Bank, for instance, said it is focused on growing its capital markets business in the U.S.

"As we see the economy pick up, capital markets divisions tend to benefit from that."

"It's another element of diversification away from domestic retail banking," Tuttle said.

"Commercial lending tends to offer more favourable profit margins than mortgage lending, so that would be a boost as well."

While Canadian banks are already considered among the most efficient compared to global peers, some may reduce the size of their workforce to save money, Lewandowski said.

"The fundamentals of our businesses are strong, but we face headwinds..."


In wake of new rules, Canada Mortgage and Housing sees Q1 profit fall

Canada Mortgage and Housing Corp. says its earned \$378-million in the first quarter, down 15% from the same time last year, as it saw smaller gains on its investments. The Crown corporation provides a variety of services, including mortgage insurance. At the end of the first quarter of 2013, CMHC's total insurance-in-force was \$562.6-billion, \$3.5-billion lower than the insurance-in-

force at year end 2012. The agency is limited to \$600-billion in total outstanding insured amounts. The lower earnings came as the market saw fewer housing starts and re-sales and tighter lending rules brought in last summer by Finance Minister Jim Flaherty. CMHC said only 0.85% of

its mortgage insurance policies was in arrears during the quarter, unchanged from a year earlier. It expects about \$60-billion to \$65-billion of mortgage repayments annually. *The Canadian Press*

Canadian housing prices seen falling, not crashing

Expected to dip 5% in next few years

Canadian house prices will fall 5% in the next few years, with Vancouver and Toronto leading the drop, but the government has done enough to cool the once-hot housing market and Canada will see a U.S.-style crash, according to a new poll.

The survey of 21 experts who showed about half have some level of concern that Canadian house prices are at risk of a sharp fall, but none believes the correction will result in the devastation seen in the United States five years ago.

"Housing slowdown is already well underway in Canada, but it is not having a widely expected by both private economists and policymakers. Home sales fell 3.3% in April

from a year earlier, but they edged up from the prior month as spring buyers breathed life back into the market that had been cooling all winter.

"Government policies have been largely successful in slowing real estate activity, in conjunction with a notable decline in interest rates. House prices are clearly vulnerable to a correction in nominal terms, but we believe a more gradual adjustment in real home prices is more likely," said Moody's Analytics senior economist Mark Hopkins.

The prospect of a soft landing has been helped by Canada's more conservative approach to home ownership and mortgage lending, including government moves to tighten lending rules in recent years.

In addition, mortgage interest is not deductible, lenders are less likely to securitize mortgages, and there is little subprime lending. Canadians are saving more equity in their homes than Americans did.

"Tighter mortgage rules have slowed credit growth, helping to cool

the housing market in an orderly fashion — hat tip to policymakers," SMC Capital Markets senior economist Sal Guatieri said in a recent housing report.

Canada is now experiencing a slowdown in housing activity just as the U.S. housing market is showing clear signs of recovery, making the comparison between the two markets more stark.

U.S. house prices crashed as a mortgage crisis unraveled in 2008, triggering a financial crisis and leaving a trail of foreclosures, negative equity and financial hardship for millions of people. But U.S. housing prices and construction are showing remarkable resilience, despite a post-financial crisis boom ends.

On a national basis, Canadian house prices are expected to drop 5% over the next several years, according to the median result of the poll, which was conducted over the past week.

Prices, which rose some 80% in the past 10 years, according to the Bank of Canada's National Housing Index, are still rising on a national basis, but the appreciation has slowed to a crawl and some markets have seen outright declines.

House prices will fall 0.2% in 2013 and rise 0.5% in 2014, according to the median of forecasts in the RE/MAX survey. The median forecast of the lowest price in each city is at least two years away and making the downward path very gradual.

Economists have long debated whether moves by the government to tighten lending standards have helped the housing sector manage a soft landing or pushed it into a crash. Only two of 21 surveyed said they expect the government to make a similar move in the next 12 months.



HYDRO ONE NETWORKS INC. HAS APPLIED TO RAISE ITS ELECTRICITY DISTRIBUTION RATES.

Hydro One Networks Inc. has applied to the Ontario Energy Board to increase the amount it charges by about \$0.07 each month for the typical residential customer beginning in January 2014. Other customers, including businesses, may be affected as well.

Hydro One applied under the Board's guidelines for 3rd Generation Incentive Regulation Mechanism which provides for a rate increase that is equivalent to distribution rates brought in as a result of application. Hydro One has also requested a Smart Grid Program Rider to recover \$20.3 million in costs for their Smart Grid Program, which will, if approved, increase a typical residential bill by \$1.15 per month until December 31, 2014 and has also requested a change to its Retail Transmission Service rates.

THE ONTARIO ENERGY BOARD IS HOLDING A PUBLIC HEARING

The Ontario Energy Board (OEB) will hold a public hearing to consider Hydro One's request. We will question the company on its case for a rate increase. We will also hear arguments from individuals and from groups that represent Hydro One customers. At the end of this hearing, the OEB will decide what, if any, increase will be allowed.

Distributors typically apply for a full review of their rates every four or five years. Any rate changes for the years in between are automatically tied to inflation (and other factors intended to promote efficiency).

The OEB is an independent and impartial public agency. We make decisions that serve the public interest. Our goal is to promote a financially viable and efficient energy sector that provides you with reliable energy services at a reasonable cost.

BE INFORMED AND HAVE YOUR SAY

You have the right to information regarding this application and to be involved in the process.

You can:

- review Hydro One's application on the OEB's website now,
- sign up to observe the proceeding by receiving OEB documents related to the hearing,
- file a letter with your comments, which will be considered during the hearing,
- become an active participant (called an intervener). Apply by June 10, 2013 or the hearing will go ahead without you and you will not receive any further notice of the proceeding,
- at the end of the process, review the OEB's decision and its reasons on our website.

Plus de contrôle aux municipalités

Le gouvernement de l'Ontario veut donner plus de contrôle aux municipalités de la province sur l'emplacement des projets d'énergie verte d'une capacité de production supérieure à 500 kilowatts. Aucune nouvelle installation collinaire ou solaire ne pourraient même voir le jour sans le consentement des élus locaux, a déclaré l'Énergie, hier.

Le illustré à Queen's Park promettent aussi de revoyer les règles du Programme de tarifs de rachat garantis pour les installations d'une capacité de production inférieure à 500 kilowatts, afin de donner la priorité aux projets dans lesquels les municipalités sont partenaire.

Il est certain également que nous devons initier des change-

ments pour augmenter le contrôle local du choix d'emplacement des projets d'énergie renouvelable. Ces changements donneront la possibilité aux collectivités et aux municipalités de se faire mieux entendre et d'obtenir un plus grand nombre d'options et de nouveaux outils en ce qui a trait à l'énergie renouvelable», a déclaré M. Chiarelli.

Plusieurs municipalités sont montées aux barricades pour empêcher des promoteurs d'aménager des collinaires de grande taille ou des parcs solaires sur leur terrains, déplorant que la province a entreposé son virage vert, il y a trois ans.

Le gouvernement de Kathleen Wynne a demandé à la Société Indépendante d'exploitation du réseau d'électricité (SIRE) et à l'Office de l'électricité de l'Ontario (OEO) de mener des consultations sur le développement de «plans

énergétiques régionaux afin de s'assurer que la province prend les bonnes décisions quant à l'emplacement des projets.

Les libéraux veulent éviter d'autres controverses comme l'annulation de deux projets de centrales électriques au gaz naturel, à Mississauga et à Oakville, à des fins potentiellement électoralistes. La manœuvre aurait coûté plus de 505 millions.

M. Chiarelli, un député d'Ottawa, a promis de faire le ménage au sein de l'énergie depuis qu'il a hérité de ce portefeuille, à la mi-février. L'Ontario éliminera, par ailleurs, l'obligation pour les fabricants d'éoliennes et de panneaux solaires d'utiliser un certain pourcentage de matériaux produits dans la province, afin de satisfaire l'Organisation mondiale du commerce (OMC) qui a jugé cette pratique déloyale.

Vallée-de-la-Gatineau

La région la moins branchée au Québec

La municipalité régionale de comté (MRC) de la Vallée-de-la-Gatineau est la moins branchée au Québec, révèlent les plus récentes données de l'Institut de la statistique du Québec (ISQ). Selon les statistiques pour l'année 2012, plus de huit ménages québécois sur dix (81,6 %) sont branchés à Internet. Des écarts importants sont toutefois observés entre les différentes villes et les MRC de la province. La MRC de Gatineau est la moins connectée du Québec, avec un taux de branchement à Internet de 79,6 %, tandis que la MRC de la Vallée-de-la-Gatineau arrive au dernier rang, avec un taux de 57,9 %. Pour l'ensemble de la région de l'Outaouais, 60,3 % des ménages sont branchés à Internet. C'est sur le territoire de la Ville de Gatineau que la proportion

de ménages branchés est la plus élevée. Les données recueillies par l'ISQ montrent aussi que la grande majorité (94,4 %) des ménages ayant une connexion Internet en ont une à haute vitesse.
