AND IN THE MATTER OF an Application by Natural Resource Gas Limited for an Order or Orders approving or fixing just and reasonable rates and other charges for the sale, distribution, transmission and storage of gas effective October 1, 2013.

PROCEDURAL ORDER NO. 1

Natural Resource Gas ("NRG") filed an Application on April 22, 2013 with the Ontario Energy Board (the "Board") under section 36 of the *Ontario Energy Board Act, 1998*, S.O. c.15, Sched. B, as amended, for an order of the Board approving or fixing rates for the distribution, transmission and storage of natural gas, effective October 1, 2013. The Board assigned file number EB-2013-0183 to the Application and issued a Notice of Application on May 10, 2013.

Intervenor status was requested by Union Gas Limited ("Union") and Integrated Grain Processors Co-operative ("IGPC"). The Board grants intervenor status to Union and IGPC. A list of intervenors in this proceeding is attached as Appendix A to this Order.

The Board will make provision for the following procedural matters. Please be aware that further procedural orders may be issued from time to time.

THE BOARD ORDERS THAT:

- Intervenors and Board staff who wish information and material from NRG that is in addition to the evidence filed with the Board, and that is relevant to this proceeding, shall request it by written interrogatories filed with the Board and delivered to NRG on or before **Monday**, **July 8**, **2013**.
- NRG shall file with the Board complete responses to the interrogatories and deliver them to the intervenors no later than Friday, July 19, 2012.
- 3. Intervenors and Board staff who wish to make a written submission must file their submissions with the Board and deliver them to NRG and other intervenors on or before **Friday**, **July 26**, **2013**.
- If NRG wishes to file a written reply submission, it must file a response with the Board and deliver the submission to intervenors on or before Wednesday, August 7, 2013.

All filings to the Board must quote file number **EB-2013-0183** and be made through the Board's web portal at https://www.pes.ontarioenergyboard.ca/eservice/, and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Please use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at www.ontarioenergyboard.ca. If the web portal is not available you may email your document to BoardSec@ontarioenergyboard.ca. Those who do not have internet access are required to submit all filings on a CD or in PDF format, along with two paper copies. Those who do not have computer access are required to file seven paper copies.
