Tribute Resources Inc. Announces Acquisition of the Chatham C Pool

London, Ontario CANADA, April 30, 2008 /FSC/ - Tribute Resources Inc. (TRB - TSX Venture), ("Tribute") is pleased to the closing of the purchase of the natural gas storage rights for the pool known as Chatham C which is located in the Township of Chatham, Regional Municipality of Chatham Kent, Province of Ontario.

On April 11, 2008 Tribute executed an Agreement of Purchase and Sale to acquire 100% of the natural gas storage rights for the Chatham C Pool from insiders of Tribute. The Chatham C Pool was purchased for \$1.37 million cash. This value is supported by an independent report prepared by Dr. Philip Walsh in which Dr. Walsh determines that the value is "fair and reasonable to the existing shareholders of Tribute" and is "fair and reasonable considering the current market value for similar undeveloped natural gas storage assets in Ontario and New York." The above purchase has been approved by the TSX Venture Exchange and has been approved by the independent directors of Tribute.

The Chatham C pool is a depleted natural gas pinnacle reef with estimated working natural gas storage capacity of .683 billion cubic feet ("BCF") and is similar in characteristics to the Chatham D pool, a designated and operating natural gas storage pool owned and operated by Enbridge Gas and located approximately 6.8 kilometers from Chatham C.

With the above purchases, Tribute now owns undeveloped natural gas storage assets in Ontario with an estimated working storage capacity of 9 BCF. In addition, Tribute recently began injection into its first developed natural gas storage pool, Tipperary which is estimated to hold 3.2 BCF of working storage capacity when fully developed. Tribute partnered with Union Gas Limited to develop the Tipperary Pools and retained a twenty five percent interest in the project.

The Chatham purchase is the beginning of storage development for Tribute outside the Huron County area. Tribute intends to acquire additional potential natural gas storage in Chatham Kent and Lambton Counties by the purchase of existing pools suitable for storage and by pursuing an active drilling program in the area.

Tribute Resources Inc. is a publicly traded junior energy company with a primary focus on developing and holding market-based natural gas storage assets in the Province of Ontario. Tribute continues to explore for and produce oil and natural gas and has invested in renewable energy projects.
