The average traffic counts corresponding to the segments of the proposed transmission line routes identified in Interrogatory #3 are correct as per 2011 counts. However, since the term of the agreements for the wind turbines in the Applications is for 20 years, it is a reasonable expectation that traffic volumes will rise to the levels indicated in the Roadside Safety Manual of 1500 to 5999 as pertaining to the measurement of clear zone width. It is professionally appropriate when considering the potential use of road allowances to properly account for clear zone width provided for in the Roadside Safety Manual.
