TransCanada has the following interrogatories for Gaz Metro Limited Partnership ("GMLP") regarding its evidence filed on June 28, 2013, in the above-noted proceeding (Exhibit L.EGD.SCGM).

Preamble: GMLP states on page 9 of 16 that "potential gas supply savings would be achieved by buying at the Dawn Hub ranging from \$88 M and \$120 M based on TransCanada's current and proposed tolls."

- 1. Please provide the detailed calculations and assumptions used in arriving at the \$88 \$120 M savings including TransCanada toll assumptions and unit gas cost assumption at each purchase point.
- 2. If the calculations in 1. above do not use the TransCanada tolls approved by the NEB for July 01, 2013, please update the calculations to reflect those tolls.
- 3. Please perform the same calculations using the gas cost assumptions used by Union in EB-2013-0074 Schedule 11-3. Again please provide all details supporting the calculations.
