### NOTICE OF APPLICATIONS AND WRITTEN HEARING Onit Energy Limited Applications for Electricity Retailer Licence and Gas Marketer Licence

# The Applications

Onit Energy Limited ("Onit") filed an application with the Ontario Energy Board (the "Board") under section 60 of the *Ontario Energy Board Act, 1998,* (the "Act") to renew its electricity retailer licence. The granting of this licence would enable Onit to continue to retail electricity in Ontario. The Board has assigned the application file number EB-2013-0076.

Onit also filed an application with the Board under section 50 of the Act to renew its gas marketer licence. The granting of this licence would enable the applicant to continue to market natural gas in Ontario. The Board has assigned the application file number EB-2013-0077.

The applications will be decided by an employee of the Board who has been delegated this authority pursuant to section 6 of the Act. Due to the similar nature of the applications, the applications will be combined into one proceeding pursuant to section 21(5) of the Act. The employee does not intend to provide for an award of costs when deciding the applications.

## How to see Onit's Applications

A copy of the non-confidential portion of the applications and related documents are available for inspection at the Board's office in Toronto. A copy can also be viewed at the applicant's office at the address indicated below.

## How to Participate in the Hearing

The Board intends to proceed with these applications by way of written hearing unless a party satisfies the Board that there is a good reason for not holding a written hearing. If you object to the Board holding a written hearing for these applications, you must provide written reasons why an oral hearing is necessary. Any submissions objecting to a written hearing must be received by the Board and copied to the applicant by **August 16, 2013**.

Any parties who wish information and material from the applicant that is in addition to the applicant's pre-filed evidence with the Board, and that is relevant to the hearing, shall request it by written interrogatories filed with the Board and delivered to the applicant on or before **August 23, 2013**. Where possible, the questions should specifically reference the pre-filed evidence. The applicant shall file with the Board complete responses to the interrogatories and deliver them to any interested parties in the proceeding no later than **September 13, 2013**.

Anyone who wishes to make a submission on the applications must file that written submission with the Board and deliver it to the applicant by **October 4, 2013**. If the applicant wishes to respond to the submission(s), the written response must be filed with the Board and delivered to all parties who made submissions by **October 25, 2013**. All written submissions will be available for viewing at the Board's offices and will be placed on the Board's website.

If the written submission is from a private citizen (i.e., not a lawyer representing a client, not a consultant representing a client or organization, not an individual in an organization that represents the interests of consumers or other groups, and not an individual from a regulated entity), before placing the written submission on the public record, the Board will remove any personal (i.e., not business) contact information from the written submission (i.e., the address, telephone number and email address of the individual). However, the name of the individual and the content of the written submission will become part of the public record.

As stated elsewhere in this notice, you must provide a complete copy of your written submission (including your name, contact information, and everything written in the submission) to the applicant.

### How to File Documents with the Board

You must forward two paper copies, and if possible, an electronic copy in PDF format of your documents to the Board and one copy to the applicant. All filings must include file numbers EB-2013-0076 and EB-2013-0077 and clearly state the sender's name, postal address, telephone number and email address. All communications should be directed to the attention of the Board Secretary at the address below, and be received no later than 4:45 p.m. on the required date.
