Applications for Electricity Generation Licences

Met Fiera Solar Orillia 1 L.P., Met Fiera Solar Orillia 2 L.P., Met Fiera Solar Breen 2 L.P., Met Fiera Solar Midhurst 2 L.P., Met Fiera Solar Midhurst 3 L.P., Met Fiera Solar Midhurst 4 L.P., Met Fiera Solar Midhurst 6 L.P. and Met Fiera Solar Adelaide 1 L.P. have applied to the Ontario Energy Board for electricity generation licences as Feed-In Tariff Program participants. The granting of these licences would enable the applicants to generate electricity in Ontario.

The applications will be decided by an employee of the Board who has been delegated this authority pursuant to section 6 of the Act. The applications will be combined into one proceeding pursuant to section 21(5) of the Act. The employee does not intend to provide for an award of costs when deciding the applications.

Copies of the application and the pre-filed evidence in support of the applicant's application will be available for public inspection at the Board's offices, or at the applicant's offices.

How to Participate in the Hearing

The Board intends to proceed with this matter by way of a written hearing unless a party satisfies the Board that there is a good reason for not holding a written hearing. If you object to the Board holding a written hearing in this matter, you must provide written reasons why an oral hearing is necessary. Any submissions objecting to a written hearing must be received by the Board and copied to the applicant by August 19, 2013.

If you wish to participate in the written hearing, please file a written submission setting out your views on the application. You must forward two paper copies, and if possible, an electronic copy in Word format and in searchable PDF format, of your submission to the Board and one copy to the applicant at the addresses below. All submissions must be received August 23, 2013. If the applicant wishes to respond to the submissions, such response must be filed with the Board and copied to any party that made submissions by August 30, 2013.

All submissions must quote the relevant file numbers, and clearly state the sender's name, postal address, telephone number, fax number and e-mail address. All communications should be directed to the attention of the Board Secretary at the address below, and be received no later than 4:45 p.m. on the required date.

All written submissions sent to the Board will be placed on the public record, which means that the written submissions will be available for viewing at the Board's offices and will be placed on the Board's website.

If the written submission is from a private citizen (i.e., not a lawyer representing a client, not a consultant representing a client or organization, not an individual in an organization that represents the interests of consumers or other groups, and not an individual from a regulated entity), before placing the written submission on the public record, the Board will remove any personal (i.e., not business) contact information from the written submission (i.e., the address, fax number, phone number, and e-mail address of the individual). However, the name of the individual and the content of the written submission will become part of the public record.

As stated elsewhere in this notice, you must provide a complete copy of your written submission (including your name, contact information, and everything written in the submission) to the applicant.
