You are directed:

Publication must be made in one issue of the English-language daily newspapers and one issue of the English language weekly newspapers having the highest circulation, according to the best information available, throughout Union's service areas. Publication must also be made in one issue of any French daily newspaper, if available, and one issue of all weekly French language newspapers throughout Union's service areas.

To immediately, and no later than the date of publication of the Notice, serve a copy of the Notice in both the English and French versions, together with a copy of the Application, either personally, by courier, or by registered mail on the Clerks of all municipalities in which Union Gas Limited ("Union") supplies gas, and the English version only, together with a copy of the Application, on all First Nation Bands and First Nation Reserves to which Union supplies gas, on the Métis Nation of Ontario, on all intervenors in EB-2011-0210, on Enbridge Gas Distribution Inc., and on Natural Resource Gas Limited;
- 4. To file with the Board an affidavit proving publication and service of the Notice and that a copy of the application, evidence and Notice are available for public review at Union Gas Limited's office and on its website.
- 5. To make a copy of the application and evidence, and any amendments thereto, available for public review at Union Gas Limited's office and on its website.
