I am writing to you to express my concern and opposition to the planned placement of a high voltage transmission line along Concession 4 Road West, in the Township of West Lincoln, Ontario.

The proposed transmission line will run along the northerly frontage of my property, located at 6374 Concession 4 Rd., W..

Here are my concerns.

1. There is documented scientific evidence that electromagnetic radiation does have health effects on human beings and animals. Having this transmission line in front of my property will
put my family in direct contact with the electromagnetic radiation for which there is no known
insulator or protection other than distance from source.
2. My property value will be severely diminished, since no clear thinking individual would buy a
property close to this environmental hazard.
3. Safety- Since this high tension line will be buried, there is a high probability of stray voltage
affecting my safety when the voltage is greater than the ability of the ground plane to safely
disperse it. Any time I am in the vicinity of this transmission line, especially in wet conditions,
I will run the risk of being affected by any negative circumstances that may arise. Who compensates me or my estate for the screw-ups of these criminals ramming these wind turbines and related infrastructure down our throats? Who pays for the damage when the inevitable damage occurs?
4. Bell already has difficulty providing a stable, noise free phone line to us. This high voltage line,
running parallel to the phone line will cause additional interference. Who pays to remediate

5. All attempts to get anyone from the Ontario government to actually come to the property to

see the physical layout and the actual reasons for my concern have been turned down and neglected. Will someone from the board actually come out to see why this project is such a bad idea?

I am writing this email, knowing full well that your board is just another organization created to appear as if the people of Ontario actually have a voice. Your sole purpose is to be another tax sucking appendage of a government that is actually an enemy of the people whose hard earned wealth is extorted from them without the ability to control how it is spent.
