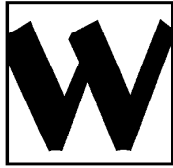

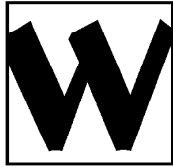
**Re: EB-2011-0140 - Designation of A Transmitter to Carry Out Development Work  
for The East-West Tie Line – Phase 2 Cost Submission**

---

We are solicitors representing the Coalition of The Corporation of the City of Thunder Bay (the “City”), the Northwestern Ontario Municipal Association (“NOMA”) and the Northwestern Ontario Associated Chamber of Commerce (“NOACC”), (hereinafter the “Thunder Bay, NOMA and NOACC Coalition” or the “Coalition”). The members of the Coalition are Intervenor parties in the above-noted proceedings.

Pursuant to the Board’s Decision on Intervention and Cost Award Eligibility, dated March 30, 2012, and the Board’s Phase 2 Decision and Order dated August 7, 2013, we are pleased to file with the Ontario Energy Board, and serve Canadian Niagara Power Inc., Five Nations Energy Inc., Great Lakes Power Transmission LP and Hydro One Networks Inc. with the Thunder Bay, NOMA and NOACC Coalition’s cost claim. Attached please find 6 Cost Claim for Hearing Forms prepared according to section 10 of the Board’s Practice Directions on Cost Awards and corresponding detailed account summaries.

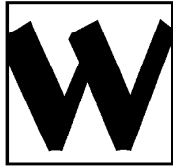
The Board’s Decision on Intervention and Cost Award Eligibility, dated March 30, 2012 provides the Thunder Bay, NOMA and NOACC Coalition the opportunity to seek costs in relation to the Board’s Proceeding to Designate a Transmitter to Carry Out Development Work For the East-West Tie Line. The Thunder Bay, NOMA and NOACC Coalition’s time and disbursements to date for the above noted proceeding related predominantly to the preparation and filing of interrogatories, preparation for and attendance at oral hearings held on May 2<sup>nd</sup> and 3<sup>rd</sup>, 2013, submissions on May 9, 2013, and the review and following of e-mails, position statements, applications,



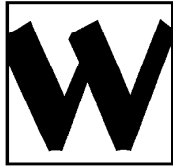
interrogatories, responses to interrogatories, arguments and reply arguments of the proponent transmitters and other parties.

In determining the amount of costs awarded to the Coalition we ask the Board to consider various distinguishing features of the Northwest Region.

1. Northwestern Ontario is by far the largest of the geographical regions in Ontario comprising some 45% to 50% of the entire land mass of the province.
2. The Northwest Region has a population of approximately 250,000 (less than 3% of the population of Ontario) in an area into which southern Ontario would fit five times over.
3. The City of Thunder Bay represents the direct interests of approximately 110,000 of its own population comprising about 45% of the population of the whole of the Northwest Region. The City is the major municipal centre for northwestern Ontario. It is the largest city centre in Ontario west of Sudbury.
4. It must not be assumed, therefore, that analyses that are applicable in the densely populated southern region of the province are appropriate for the challenges that face the Northwest Region.
5. The City of Thunder Bay is the westerly terminus of the Proposed East West Tie Line.
6. The Thunder Bay Generating Station is the source of 306 MW of dispatchable power generation.
7. NOACC represents the direct interest of the associated Chambers of Commerce in their capacity as forums for small commercial and business consumers, throughout the Northwest Region. Those consumers are often dependent on a single industrial employer in a town. The viability of a single industrial plant can be essential to the livelihood of an entire community. Reliability of power supply has a direct bearing on that viability.
8. NOACC and NOMA, through their Energy Task Force, have created a regional research committee of interested and experienced individuals who by living and working in the Northwest Region are keenly aware of the geographical and technical issues relating to electricity generation, transmission and distribution of power in the Region.
9. The Thunder Bay, NOMA and NOACC Coalition is directly familiar with the unique requirements relating to electricity generation, transmission and



- distribution in the Northwest Region, and as such can provide important perspectives in selection of the most qualified and cost-effective electricity transmitter to develop the East-West Tie Line.
10. The Thunder Bay, NOMA and NOACC Coalition represent persons with a significant interest in land that is, or may be, affected by the East-West Tie Line. That interest in very general and indirect terms is related to the economy of the Northwest Region as a whole and, in some instances, may be a private interest, but in every case represents an overriding public interest.
  11. There has been continual co-operation by the Thunder Bay, NOMA and NOACC Coalition through their Energy Task Force in the collection of information and consultation with relevant stakeholders in the Northwest Region, including First Nations, large industry and municipalities.
  12. Many issues the East-West Tie Line presents to the northwest are technical in nature and therefore a review of literature and research on complex topics such as power reliability and quality has been undertaken. Furthermore, the amount of documentation flowing from various other Intervenor to the Ontario Energy Board has been, and continues to be, extensive. The Thunder Bay, NOMA and NOACC Coalition had to review all documents on the public record, to ensure the interests of the Thunder Bay, NOMA and NOACC Coalition were appropriately communicated to the Board.
  13. In light of costs associated with the representation of the many parties who form the Thunder Bay, NOMA and NOACC Coalition, the Thunder Bay, NOMA and NOACC Coalition pleads and relies on section 8.01 of the Board's Practice Direction on Cost Awards so that the Board may recognize the collaboration involved in the Thunder Bay, NOMA and NOACC Coalition's efforts in preparing and presenting submissions and written comments.
  14. Collaboration of the City of Thunder Bay with NOMA and NOACC.
    - (a) The Thunder Bay, NOMA and NOACC Coalition prepared interrogatories (January 30, 2013), presentations (May 2<sup>nd</sup> and 3<sup>rd</sup>, 2013), submissions (May 9, 2013) that described the concerns of the Coalition as well as the rationale for these concerns. The Thunder Bay, NOMA and NOACC Coalition submits that the submissions will assist the Board, OPA and other Intervenor to better understand the position of the Thunder Bay, NOMA and NOACC Coalition and help create a more useful and focused record.



- (b) The Thunder Bay, NOMA and NOACC Coalition shared technical and legal advice resources so as to minimize the cost to prepare, review, and gather information for submissions.
15. Personal attendance at the Oral Hearing on May 2<sup>nd</sup> and 3<sup>rd</sup>, 2013 was limited to only one representative (Nick A. Melchiorre) on behalf of the Thunder Bay, NOMA and NOACC Coalition.
16. The Thunder Bay, NOMA and NOACC Coalition provide their collective questions, submissions and argument in relation to issues not only related to energy infrastructure but also to the broader environmental and other social imperatives important to the Northwest Region, including but not limited to the geographic challenges as well as the economic and commercial needs and well being of the Northwest Region.
17. The City, NOACC and NOMA have been and will continue to be proponents of regionally based coordinated, comprehensive, and transparent planning of electricity infrastructure in the Northwest.
