**Re: EB-2011-0030 – ABW Solar General Partnership (ABW Partnership)
Electricity Generation Licence EG-2011-0030**

**Written Confirmation of Closing of Transfer of Generation Facilities and
Request for Transferor Licence Cancellation.**

By Decision and Order herein issued May 11, 2011, ABW Partnership was granted Electricity Generation Licence EG-2011-0030. The Decision and Order was premised on ABW Partnership acquiring from First Solar Development (Canada) Inc. (First Solar) ownership of the following generation facilities identified in the application:

1. Belmont Solar 1 Project 1017.
2. Belmont Solar 2 Project 1018.
3. Amherstburg Solar 1 Project 1172.
4. Walpole Solar 1 Project 10650.
5. Walpole Solar 2 Project 10720.

By Decision and Order dated April 11, 2013 in EB-2013-0006/0012, ABW Partnership's licence was amended to include operational authority for the identified facilities in addition to ownership authority.

In both cases the Decision and Order provided that Schedule 1 of ABW Solar's licence, which ordinarily describes the generation facilities for which the applicant is being licensed, will remain incomplete until the Board receives written confirmation from ABW Partnership and First Solar that the commercial transaction has closed. The Decision and Order in both cases also required that, at the same time, First Solar must file a letter to the Board to cancel its electricity generation licence (EG-2006-0336).



We are pleased to advise the Board that the commercial transaction for transfer of the generation facilities listed in ABW Partnership's licence application and above has now closed. Attached to this letter is signed confirmation from both ABW Partnership and First Solar acknowledging closing of the commercial transaction. Through the attached confirmation First Solar is also requesting, and has authorized us to file on its behalf its request for, cancellation of Electricity Generation Licence EG-2006-0336.

Accordingly, in accord with the Decision and Orders referenced above, we request that the Board:

1. Issue a completed Schedule 1 for ABW Partnership's Electricity Generation Licence EG-2011-0030, listing the facilities identified above.
2. Cancel First Solar's Electricity Generation Licence EG-2006-0336.


