Agreement Name	<b>Description or Comments</b>	
Category 1 – New Agreements		
[1] Confidentiality and Non-Disclosure Agreement, dated July 24, 2013.	Bruce Power and OPG are in discussions regarding possible collaborations on the development of nuclear plant inspection and maintenance technology and processes. During these discussions, both parties will disclose certain information to each other which is confidential, non-public and proprietary. This agreement, effective July 24, 2013, sets out the terms for exchange, possession and use of such information.	
[2] Memorandum of Understanding ("MOU") for Bruce Power Access to OPG Retained Land to install 13.8 kV Line, dated August 8, 2013	As part of a site infrastructure renewal initiative, Bruce Power will install a permanent 13.8 kV power line which requires access to OPG's Retained Facilities. This MOU grants Bruce Power temporary access to the Retained Facilities.	
[3] Legacy Records Retrieval Service Agreement, dated August 19, 2013.	This agreement provides Bruce Power with an OPG records retrieval service for certain intellectual property and service materials not previously delivered as contemplated in previous and now expired agreements.	
[4] First Supplement and Amendment to the Inspection and Maintenance Services IP and Gap IP Intellectual Property License Agreement, dated August 19, 2013.	In June 2010, OPG entered into two agreements, the Master Transition Agreement and the Intellectual Property ("IP") License Agreement, regarding the termination of inspection and maintenance services to Bruce Power. Under the IP License Agreement, OPG provides Bruce Power licenses and rights to possess and use intellectual property all to be identified by Bruce Power by December 6, 2012. This supplement and amendment extends the term of identifying and OPG delivering the intellectual property required by Bruce Power to perform inspection and maintenance services.

Bruce Power and OPG amended and restated the Confidentiality and Non-Disclosure Agreement for Joint Collaboration Agreement, dated July 24, 2013, by clarifying certain definitions and expanding the scope of the project identified in the original agreement.	
Category 3 – Expired or Terminated Agreements		
[1] Deferred Delivery Agreement, dated May 11, 2001.	This agreement terminated upon the execution of the Legacy Records Retrieval Service Agreement (the "LRRS"), with all outstanding obligations being transferred to the LRRS.
