# EB-2012-0137 – Hydro One Remote Communities Inc. 2013 Revenue Requirement and Rates Application – Response to Board Staff and Intervenor Comments on Draft Rate Order

Hydro One Remote Communities Inc. ("Remotes") is providing an updated Draft Rate Order using the current template as suggested by Board Staff.

Remotes notes that neither Board Staff nor any intervenor has objected to the calculation of the draft foregone revenue rate riders or the timeframe for recovery of these revenues proposed in the draft Rate Order. Remotes therefore requests, that the Board accept the proposed rates as presented.

In its Submission dated September 9, 2013, Board staff suggested that ambiguity would be avoided if the Board's Rate Order were to state that the tariff does not yet apply to Non-Standard A customers in the grid-connected communities. Remotes' response is that there is no ambiguity. The Board's Decision and Order approved both Standard A and non-Standard A rates for grid-connected geographically remote customers.

Inclusion of these Board-approved rates in the Rate Order not only accurately reflects the Board's Decision and Order, but also provides approved rates for the ongoing discussions with Cat Lake and Pikangikum. These communities are assisted by knowing the applicable rates prior

to making final decisions to be served by Remotes. Remotes submits that the Board-approved Standard A, grid-connected rate should be included in the Rate Order to reduce potential confusion for the communities and for the Government as these approvals are sought.

Additionally, Remotes further notes that many of the communities it currently serves are contemplating grid connections. As stated in its Application, Remotes believes that the approval of rates for grid-connected, geographically remote customers will give the communities it currently serves the option of being served by an established distribution company. The Board-approved rates from this proceeding are generic in nature and will be applicable to any grid-connected, geographically remote community that Remotes serves.
