AND IN THE MATTER OF an application under section 50 of the *Ontario Energy Board Act, 1998* by Onit Energy Limited for a Gas Marketer Licence.

PROCEDURAL ORDER No. 1 September 27, 2013

Onit Energy Limited ("Onit Energy") filed two applications to renew its electricity retailer and its gas marketer licences on March 20, 2013. The Board assigned the applications file numbers EB-2013-0076 and EB-2013-0077, respectively. Onit Energy filed information to complete the applications on July 10, 2013.

The Board issued a Notice of Application and Hearing on August 2, 2013 setting out the dates for the filing of interrogatories and submissions from interested parties. Board staff filed interrogatories on August 23, 2013. Interrogatory responses from the applicant were due on September 13, 2013, and submissions from interested parties were due on October 4, 2013. Onit Energy responded to Board staff interrogatories on September 24, 2013.

On September 26, 2013, Board staff filed a letter requesting an extension of time until October 16, 2013 to make submissions to the Board and also requested that Onit Energy's reply submission be filed within two weeks of Board staff's submission being filed.

The Board has decided to grant the request of Board staff to allow sufficient time for the completion and filing of a submission from Board staff, and a reply submission from the applicant.

THE BOARD ORDERS THAT:

- 1. If Board staff wishes to make a submission on the applications, Board staff must file that submission with the Board, and deliver it to Onit Energy by **October 16, 2013**.
- 2. If Onit Energy wishes to file a response to a submission, the response must be filed with the Board by **October 30, 2013**.

All filings to the Board must quote the file numbers, EB-2013-0076 and EB-2013-0077, consist of two paper copies and one electronic copy in searchable / unrestricted PDF format made through the Board's web portal at <u>www.errr.ontarioenergyboard.ca</u>. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties should use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at <u>www.ontarioenergyboard.ca</u>. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
