NOTICE OF HEARING AND PROCEDURAL ORDER NO. 1

October 9, 2013

On September 4, 2013, the Ontario Energy Board (the "Board"), on its own motion under section 112.2 of the *Ontario Energy Board Act, 1998* (the "Act"), issued a Notice of Intention to make an Order under section 112.4 of the Act (the "Notice") for revocation of Energhx Green Energy Corporation's ("Energhx") electricity retailer and gas marketer licences, ER-2010-0236 and GM-2010-0237, respectively.

A Supplementary Notice of Intention (the "Supplementary Notice") was issued on October 4, 2013.

The particulars of the allegations against Energhx are set out in the Notice and the Supplementary Notice.

The Notice stated that Energhx may make a request, within fifteen days after receiving the Notice, requiring the Board to hold a hearing on these matters. By way of letter dated September 10, 2013, Energhx requested that the Board hold a hearing.

The Board has determined that it will proceed with the matters set out in the Notice and Supplementary Notice of Intention by way of oral hearing and has set aside one (1) day for the hearing. Energhx is entitled to be present at the hearing with or without counsel and to adduce evidence and make submissions. Should Energhx fail to attend, the hearing may be conducted in its absence and Energhx will not be entitled to any further notice in the proceeding.

The Board considers it necessary to make provision for the following procedural matters related to this proceeding. The Board may issue further procedural orders from time to time.

THE BOARD THERFORE ORDERS THAT:

- 1. The Board Enforcement Team shall file with the Board a copy of every document it intends to produce or enter into evidence in this proceeding and serve a copy on Energhx, on or before **October 25, 2013**.
- Energhx shall file with the Board (particulars regarding filings with the Board are below) a copy of every document it intends to produce or enter into evidence in this proceeding and serve a copy on the Board Enforcement Team Counsel (Mr. Fredrick Schumann) on or before **November 1, 2013.** Mr. Schumann's contact information is set out below:
