LETTER OF DIRECTION

Dear Mr. Waller:

**Re: Hydro One Networks Inc.'s ("Hydro One") application for leave to construct certain facilities located in the Municipalities of Lincoln, Grimsby and Hamilton in the Niagara Region
Board File No. EB-2013-0246**

On September 13, 2013, the Ontario Energy Board (the "Board") issued its Notice of Application and Written Hearing (the "Notice") in the above matter and directed Hydro One to publish the Notice in "one issue of the English language newspaper having the highest circulation, according to the best information available, in each of the City of Hamilton and the Niagara Region".

On September 27, 2013, Hydro One filed an affidavit with the Board confirming publication and service of the Notice.

It has since been brought to the Board's attention that the city of Hamilton is a designated area under the *French Languages Services Act*, and requires the Notice also be published in French. Accordingly, you are directed:

- 1) To immediately arrange for the publication of the enclosed French version of the Notice, together with the map, in the exact form accompanying this letter, except, under the second bullet of the section entitled “**DONNEZ VOTRE AVIS**” and under the heading “**Audiences orales et audiences écrites**”
 - a. remove the bold and bracketed words “[insérer la date correspondant à 10 jours calendaires suivant la publication du présent document]”; and
 - b. insert the actual date, using the following format “**1 janvier 2013**”, which date shall be determined by adding 10 calendar days to the date of publication of the newspaper in which the Notice appears.
- 2) Publication must be made in one issue of the French language newspaper having the highest circulation, according to the best information available, in the city of Hamilton.
- 3) Please note that invoices regarding publication are not to be sent to the Board.
- 4) To file with the Board a pdf version of the completed Notice as soon as the publication date is known.
- 5) To file with the Board affidavit evidence proving the above publication immediately upon completion.
