AND IN THE MATTER OF an application by Festival Hydro Inc. for an order approving just and reasonable rates and other charges for electricity distribution to be effective May 1, 2014.

PROCEDURAL ORDER NO. 1 October 29, 2013

Festival Hydro Inc. ("Festival") filed a complete application (the "Application") with the Ontario Energy Board (the "Board") on September 13, 2013 under section 78 of the *Ontario Energy Board Act, 1998*, S.O. 1998, c. 15, (Schedule B), under the Board's Guidelines for 4th Generation Incentive Regulation Mechanism. Festival is seeking approval for changes to the rates that Festival charges for electricity distribution, to be effective May 1, 2014. The Board assigned the application file number EB-2013-0129.

The Board issued a Notice of Application and Hearing on September 30, 2013. The Vulnerable Energy Consumers Coalition ("VECC") applied for intervenor status and cost eligibility in relation to Festival's proposal to harmonize base rates for the Residential and Residential – Hensall service classes. No objection was received.

The Board approves VECC as an intervenor. The list of parties in this proceeding is attached as Appendix A to this procedural order. The Board has also determined that VECC is eligible to apply for an award of costs under the Board's *Practice Direction on Cost Awards* in relation to proposal to harmonize base rates for the Residential and Residential – Hensall service classes.

The Board has decided to make provision at this time for written interrogatories, interrogatory responses, submission and reply submission. The Board may issue further procedural orders from time to time.

THE BOARD ORDERS THAT:

- 1. Board staff and VECC shall request any information and material from Festival that is in addition to Festival's pre-filed evidence with the Board, and that is relevant to the hearing, by written interrogatories filed with the Board and served on Festival on or before **November 11, 2013**.
- 2. Festival shall file with the Board complete written responses to the interrogatories and serve them on VECC on or before **November 22, 2013.**
- 3. Board staff and VECC may file a written submission by **December 6, 2013**. Any submission should be filed with the Board and delivered to all parties and Festival.
- 4. Festival may file a written reply submission with the Board, and deliver it to VECC by **December 20, 2013**.

All filings to the Board must quote the file number, EB-2013-0129, be made through the Board's web portal at https://www.pes.ontarioenergyboard.ca/eservice/, and consist of two paper copies and one electronic copy in searchable / unrestricted PDF format. Filings must clearly state the sender's name, postal address and telephone number, fax number and e-mail address. Parties must use the document naming conventions and document submission standards outlined in the RESS Document Guideline found at http://www.ontarioenergyboard.ca/OEB/Industry. If the web portal is not available parties may email their documents to the address below. Those who do not have internet access are required to submit all filings on a CD in PDF format, along with two paper copies. Those who do not have computer access are required to file 7 paper copies.
