Notice of Intervention of Brigitta Tarsoly ("Ms. Tarsoly")

We are in receipt of your email requesting intervenor status in the Milton Hydro proceeding. Section 23.02 of the Board's Rules of Practice and Procedure state that a person applying for intervenor status must satisfy the Board that he or she has a substantial interest and intends to participate actively and responsibly in the proceeding by submitting evidence, argument or interrogatories.

Section 23.03 of the Rules outlines the information that needs to be provided with every letter of intervention as follows:

- a) a description of the intervenor, its membership, is any, the interst of the intervenor in the proceeding and the grounds for the intervention;
- b) subject to Rule 23.04, a concise statement of the nature and scope of the intervenor's intended participation;
- c) a request for the written evidence, if it is desired;
- d) an indication as to whether the intervenor intends to seek an award of costs:
- e) if applicable, the intervenor's intention to participate in the hearing using the French language; and
- f) the full name, address, telephone number, and fax number, if any, or no more than two respresentatives of the intervenor, including counsel, for the purpose of service and delivery of documents in the proceeding.

The Board notes that while you have requested intervenor status you have not provided the above noted information. If you would still like to be considered an intervenor in this proceeding please provide the above mentioned information on or before November 8, 2013. Otherwise, the Board may deny your participation in the proceeding as an intervenor.

The Board would also like to bring to your attention that the increase in rates that Milton Hydro is seeking uses a Board approved, mechanistic formula. The only issue where input is sought from intervenors is with an adjustment to a minimum distribution charge that is charged to two seasonal General Service>50kW customers when their operation cease at the end of their operating season for the 2012, 2013 and 2014 rate year.
