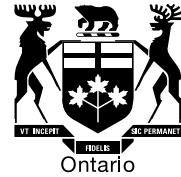

This will acknowledge receipt on October 29, 2013 of your four applications for electricity generation licences as a Feed-in Tariff Program participant. The Board has assigned file number EB-2013-0376, EB-2013-0377, EB-2013-0378, and EB-2013-0379 to these applications, respectively. Please refer to each file number in all future correspondence to the Board regarding this matter. All information related to this matter must be filed with the Board Secretary.

The Board has reviewed your applications. Your applications are currently incomplete and cannot be processed until the following has been filed:

- Section 7 (Generation Facilities) - In each of the four applications, you indicate that the applicant will be the owner only of the generation facility and identify Northland Power Inc. as the lessee/operator, and further state that you will be amending Northland Power Inc.'s electricity generation licence. Please file an application requesting an amendment to Northland Power Inc.'s electricity generation licence to include the operation of the four generation facilities.

The Board will resume processing your applications once the above information has been filed. If the above information is not filed within 30 days of the date of this letter, the Board may close the files for these applications.

Upon receipt of the required information the Board will issue an acknowledgement letter indicating the expected date on which a decision and/or order may be rendered.
