Re: Request for Intervenor Status by Robert Lewis et al
EB-2013-0361 – Jericho Wind, Inc. proposed transmission
facilities.

Dear Ms. Walli,

I, along with the people identified in Appendix A, request intervenor status, costs eligibility and an oral hearing. Each of the participating landowners is either a resident of North Middlesex, Middlesex County or Lambton Shores, Lambton County or a landowner along the route.

We seek intervenor status and costs eligibility as residents directly affected by the proposed transmission facilities. The points we hope to raise during this hearing pertain to the following issues:

- the agreements used by Jericho Wind, Inc.; and
- numerous electrical safety concerns including but not limited to the location of the Jericho substation to residences and schools, the location of high-voltage transmission lines and substation to a community recreation area, and high-voltage transmission lines located next to pastures and barns housing livestock.
- the interests of consumers with respect to prices and the reliability and quality of electricity service.
- Discrepancies between the government's promotion of renewable energy and the implementation of the policies, and conflicts with other policies of the government.

Additionally, we request an oral hearing due to the high degree of community interest in this project. Having an oral hearing will provide much needed transparency into the process, and allow the community to actively and responsibly participate in the process by calling evidence, by making arguments and by cross-examining witnesses called on behalf of the proponent. We might also wish to call expert witnesses ourselves.

We would also request that the hearing be held locally in a suitable location with microphones and video equipment.

We are also seeking a two week extension for intervenor requests for the following reasons:

- this is an extremely busy time of the year for farmers who are currently in the fields combining corn and plowing fields. As such, they have been unable to determine the impact this transmission facility will have on their land; and
- many of the residents affected by this transmission facility are unaware of this hearing because Jericho Wind, Inc. placed the hearing announcement in the London Free Press which is primarily an urban newspaper, infrequently read by people in this community who are at least a one hour drive from this city. There are two local newspapers widely read by the community:, The Parkhill Gazette and The Forest Standard. We respectfully request that the Board direct Jericho Wind, Inc. to publish the announcement in these publications to ensure the widest circulation to affected landowners.
