**Application for Electricity Retailer (Agent Only) Licence**

Amerex Brokers LLC has applied to the Ontario Energy Board for a gas marketer licence. The granting of this licence would enable the applicant to act as an agent or broker for a gas marketer and/or low-volume consumer with respect to the sale or offering for sale of natural gas in Ontario.

Amerex Brokers LLC has also applied to the Board for an electricity retailer licence. The granting of this licence would enable the applicant to act as an agent or broker for a retailer and/or consumer with respect to the sale or offering for sale of electricity in Ontario.

The applications will be decided by an employee of the Board who has been delegated this authority pursuant to section 6 of the *Ontario Energy Board Act, 1998*. Due to the similar nature of the applications, the applications will be combined into one proceeding pursuant to section 21(5) of the Act. The employee does not intend to provide for an award of costs when deciding the applications.

Copies of the applications and the pre-filed evidence in support of the applications will be available for public inspection at the Board's offices, or at the applicant's offices.
