RE: McLean's Mountain Wind Limited Partnership Application to Amend Connection Agreement with Hydro One Networks Inc.

Hydro One Networks Inc. ("Hydro One") is of the view that it is acceptable that McLean's Mountain Wind Limited Partnership ("McLean's Mountain") be relieved of its obligation to provide an isolating disconnect switch at the point of interconnection to Hydro One's 115 kV transmission circuit S2B on Manitoulin Island.

The intended electrical function of the isolating disconnect switch required by Section 1.2.1 in Schedule E of the standard form of the Transmission Connection Agreement will be performed by an isolating disconnect switch, provided by McLean's Mountain, approximately 40 metres from the interconnection point. In our assessment, relieving McLean's Mountain of its obligation to provide an isolating disconnect switch at the exact point of interconnection would have no adverse impact on system reliability, operations or safety.

To maintain a clear physical demarcation point between the customer's facilities and the transmitter's facilities in the absence of a disconnect switch at the point of interconnection, Hydro One will install, prior to connection, a mid-span opener at the point of interconnection, at McLean's Mountain's expense.

If the Ontario Energy Board (the "Board") approves McLean's Mountain's application, Hydro One intends to apply any Board-approved amendments to McLean's Mountain's connection agreement accordingly.
