Request for Intervention

NOVA Chemicals (Canada) Ltd. ("NCCL") respectfully requests intervenor status in the Ontario Energy Board ("OEB") proceeding mentioned above.

NCCL owns and operates petrochemical facilities in the Sarnia region which rely on natural gas fuel transported on the Union Gas pipeline system. NCCL is and will continue to be a long term shipper on the Union Gas system and is currently obligated to deliver volumes of gas at Parkway.

Over the past year, NCCL has participated in the Parkway Obligation Working Group ("POWG") which was established as part of the outcome of the Settlement Agreement dated June 28, 2012, pursuant to OEB proceeding EB-2011-0210. The POWG met to review Union's Parkway delivery obligation and to develop proposals for change. Union was charged with the duty to report on the proposal arising from the POWG process and other parties may bring forward other proposals within the application to set rates for 2014.

NCCL is keenly interested in and will be affected by the outcome of the Parkway Obligation issue. NCCL plans to monitor the proceedings and reserves the right to participate in all aspects of this proceeding, including evidence, interrogatories, cross-examination and argument, as necessary.
