I am writing to you regarding the ever increasing hydro prices. I am very concerned with the increase to both off-peak hours and on-peak hours, as well as the delivery charges. I am also curious about the former Ontario hydro debt, and would like to know a date as to when that will be paid off, and also would like to know, why it is my responsibility to be paying for someone else's debt!!! As far as I am concerned, hydro is not a luxury it is a necessity which we all need to survive. It is not just for the rich!!!! It is NOT a privilege to be able to heat my house or cook my food!!

When Time Of Use was implemented, many of us switched our hours, despite the inconvenience of having to do laundry at 11 pm at night, or do dishes..just to name a few examples.
