The Board has reviewed your application for an electricity retailer licence. Your application is currently incomplete and cannot be processed until the following has been filed:

**1. Section 12 – Financial Information**

The information provided consists of pro forma financial statements for the applicant for five years. Please note that these documents must be signed by one key individual. Please resubmit this information with the required signature.

In addition unaudited financial statements for Xcela Inc. have been provided. It is not clear from the application how the applicant and Xcela Inc. are related. Please provide explanation and resubmit Xcela Inc.'s statements with the required signature.

**2. Section 15 - Documents to support identity**

The photocopy of the driver's licence identification provided for Mr. Mehta does not have his signature and the licence expiry date. In addition the home address provided in section 15 of the application form does not match the home address in Mr. Mehta's drivers licence. Please provide a copy of the current driver's licence and, if necessary, amend the application to reflect the current home address for Mr. Mehta.
