1. I am employed as a Senior Analyst, Regulatory Affairs, with the Independent Electricity System Operator (“IESO”) and as such have knowledge of the matters hereinafter deposed to.
2. On January 3, 2014 the Ontario Energy Board (“OEB”) issued the Notice of Application (“Notice”) for OEB proceeding #EB-2013-0381 and by Letter of Direction directed the IESO to undertake a number of steps to provide notice through publication, notification and service. 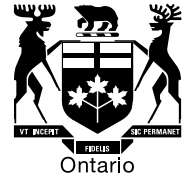

NOTICE OF APPLICATION AND WRITTEN HEARING

INDEPENDENT ELECTRICITY SYSTEM OPERATOR FISCAL 2014 FEES SUBMISSION FOR REVIEW

The Independent Electricity System Operator (the "IESO") manages Ontario's electricity system and operates the wholesale electricity market. On November 4, 2013, the IESO filed its fiscal 2014 proposed revenue requirements, expenditures and fees for review by the Ontario Energy Board pursuant to sections 18 and 19 of the *Electricity Act, 1998* (the "Application"). The Board has assigned file number **EB-2013-0381** to the Application.

The IESO is seeking the following approvals from the Board:

- Approval of its proposed 2014 revenue requirement of \$129.9 million;
- Approval of its proposed 2014 capital expenditure envelope of \$24 million for capital plans;
- Approval for the continuation of the \$1,000 application fee;
- Approval of a usage fee of \$0.803/MWh to be paid commencing January 1, 2014 by all market participants based on energy withdrawn from the IESO-controlled grid, including scheduled exports and embedded generation. The IESO proposes to continue to charge the Interim Usage Fee (\$0.822/ MWh) to market participants from January 1, 2014 until the end of the month in which Board approval is received for the 2014 usage fee.
- Approval to rely on and use the information provided to the IESO by electricity distributors on the amount of embedded generation in their service territory under O.Reg 429/04 in calculating the total usage fee to be billed to each electricity distributor each billing period.
- Approval of Interim Usage Fee as the final usage fee for each of the 2012 and 2013 fiscal years; and

- Approval to retain \$5 million of the accumulated surplus from the 2011, 2012 and 2013 fiscal years. The IESO proposes to rebate the balance of the accumulated surplus, based on the IESO's audited 2013 financial statements to market participants based on each market participant's proportionate quantity of energy withdrawn from the IESO controlled grid (including scheduled exports) for 2013.

The IESO is proposing to change its fee structure to also include energy volumes equal to the output from generation embedded in local distribution networks. Currently, those volumes are not included in the determination of the IESO fee as the fee is based on energy withdrawals net of embedded generation

Written Hearing

The Board intends to proceed with this matter by way of a written hearing unless a party satisfies the Board that there is a good reason for not holding a written hearing. If you object to a written hearing, you must provide written reasons why you believe an oral hearing is necessary. Any submissions objecting to a written hearing must be received by the Board and copied to the applicant within **10 days** of the publication or service date of this notice.

How to Participate

Comment

If you wish to give your opinion on the proceeding to the Board Members hearing the application, you are invited to send a written letter of comment to the Board no later than **30 days** after the publication or service date of this notice. A complete copy of your letter of comment, including your name, contact information, and the content of the letter, will be provided to the applicant and the Hearing Panel.

Observe

If you do not wish to actively participate in the proceeding but you do wish to receive documents issued by the Board, you may request observer status. Your written request must be received by the Board no later than **10 days** from the publication or service date of this notice.

Personal Information in Letters of Comment and Observer Requests

All letters of comment or letters requesting observer status will be placed on the public record, which means that the letters can be seen at the Board's office and will be available on the Board's website. SOUMISSION POUR EXAMEN D'UNE DEMANDE DE TARIFS POUR L'EXERCICE 2014 FORMULÉE PAR L'INDEPENDENT ELECTRICITY SYSTEM OPERATOR

L'Independent Electricity System Operator (IESO) est une société indépendante qui exploite le réseau d'électricité de l'Ontario et gère le commerce de gros d'électricité dans cette province. Le 4 novembre 2013, l'IESO a remis pour examen une requête de revenus, de dépenses et de tarifs pour l'exercice 2014 à la Commission de l'énergie de l'Ontario, conformément aux articles 18 et 19 de la *Loi de 1998 sur l'électricité* (la « requête »). La Commission a assigné à cette requête le numéro de dossier **EB-2013-0381**.

L'IESO demande à la Commission :

- d'approuver les revenus proposés pour 2014 d'un montant de 129,9 M\$;
- d'approuver les dépenses en immobilisations proposées pour 2014 d'un montant de 24 M\$;
- d'approuver le maintien des frais de requête de 1 000 \$;
- d'approuver, à compter du 1^{er} janvier 2014, la facturation à tous les acteurs du marché qui utilisent le réseau d'électricité de l'IESO d'un tarif d'utilisation de 0,803 \$/MWh, englobant les exportations prévues et la production intégrée. À partir du 1^{er} janvier 2014, et ce, jusqu'à la fin du mois où elle obtiendra de la Commission l'approbation concernant les tarifs pour 2014, l'IESO propose de continuer à facturer aux acteurs du marché des frais d'utilisation provisoires (de 0,822 \$/MWh);
- de l'autoriser à exploiter l'information donnée, conformément au règlement de l'Ontario 429/04, à l'IESO par les distributeurs d'électricité au sujet de la valeur de la production intégrée dans leur zone d'activités, pour calculer le montant total des frais d'utilisation facturés à chacun des distributeurs d'électricité à chaque période de facturation;

- d'accepter que les frais d'utilisation provisoires deviennent des frais d'utilisation définitifs pour les exercices financiers de 2012 et de 2013;
- de lui permettre de conserver 5 M\$ des bénéfices réalisés au cours des exercices financiers de 2011, 2012 et 2013. L'IESO propose de remettre le reste des bénéfices indiqués dans les résultats financiers vérifiés de 2013 aux acteurs du marché au prorata de l'électricité (y compris pour les exportations prévues) qu'ils ont obtenue en 2013 par l'intermédiaire du réseau d'électricité de l'IESO.

L'IESO propose de modifier son barème tarifaire pour inclure également les volumes d'électricité correspondant à la production intégrée dans les réseaux de distribution locaux. À l'heure actuelle, ces volumes ne sont pas compris dans la fixation des tarifs de l'IESO, car ceux-ci sont calculés sans tenir compte de la production intégrée.

IESO to launch new website

Bruce Campbell speaks to the OEN on flexibility and managing change

Reminder of Northwest transmission zone limits webinar

A webinar to inform market participants about recent revisions to the set of limits for the Northwest transmission zone will occur on January 14 from 9 am to 11 am. The session will include an overview of the unique characteristics and challenges of the zone, with particular focus on the revised operating security limits and instructions that are intended to ensure stability of the entire Northwest System. Please note that the focus for this webinar will be on the technical aspects of the changes to the northwest operating security limits.

The webinar is intended to help market participants operating within the zone to better understand the interface limitations published by the IESO and the impact of transmission outages on the transfer capability of the Northwest transmission zone.

Market participants can then more effectively use the data provided by the IESO to plan production and outages in accordance with the revised limits.

Market Rules and Market Design

Operating Reserve Market Determination

A condition of both the IESO and Ontario Power Generation (OPG) licenses requires a bid-cap agreement which governs the way that OPG offers their resources into the Operating Reserve (OR) market, unless the IESO determines that a competitive market for any category of operating reserves exists.

A recent review by the IESO concluded that this agreement is no longer required as the OR markets are effectively competitive at this time. Changes in Ontario's supply mix have broadened the composition of OR supply since the bid-cap agreement was first put in place at market opening. The agreement terminated on December 31, 2013.

Hydro Québec Transénergie 10-minute reserve testing

Hydro-Québec Transénergie (HQT), the Balancing Authority for the province of Québec, is currently testing with the IESO to look at scheduling 10-minute operating reserve (OR) in the IESO-administered market. The testing currently limits scheduled 10-minute non-spinning OR offers to 10MW at Outaouais, with one price quantity limitation.

Effective January 15, 2014, the limit will be increased to 50MW with one price quantity limitation to allow for continued testing on a larger scale. The intent of the test is to determine if operating reserve activations in the 10-minute OR market can be successful between the two balancing authorities, and to identify any technical issues either with IESO or HQT.

As mentioned in the [December 12 bulletin](#), HQT will continue to administer this testing within the limitations mentioned for those interested in participating. The results of the tests will be shared with all market participants and may point towards opening up trade for 10-minute reserve on the Québec interties if technical issues can be resolved.

Settlements

Transmission Rates set by Ontario Energy Board

Provincial Transmission Service tariffs and the Export Transmission Service tariff, effective January 1, 2014, have been set under a recent Ontario Energy Board (OEB) rate order.

The Provincial Transmission Service rates billed by the IESO are:

- Network Service Rate: \$3.82/kW of demand (up from the 2013 rate of \$3.63/kW)
- Line Connection Service Rate: \$0.82/kW of demand (up from the 2013 rate of \$0.75/kW)
- Transformation Connection Service Rate: \$1.98/kW of demand (up from the 2012 rate of \$1.85/kW)

The IESO collects OEB-regulated transmission service charges from applicable market participants and distributes payments to transmitters. These are billed monthly by the IESO using the following Charge Types:

- 650 Network Service Charge
- 651 Line Connection Service Charge
- 652 Transformation Connection Service Charge

The 2014 Export Transmission Service tariff is unchanged from the 2013 rate, at \$2.00/MWh. The ETS tariff applies to all wheel-through and export transactions from Ontario and is billed monthly by the IESO using Charge Type 653, Export Transmission Service Charge.

EB-2013-0381

The Independent Electricity System Operator (the "IESO") manages Ontario's electricity system and operates the wholesale electricity market. On November 4, 2013, the IESO filed its fiscal 2014 proposed revenue requirements, expenditures and fees for review by the Ontario Energy Board pursuant to sections 18 and 19 of the Electricity Act, 1998 (the "Application"). The Board has assigned file number **EB-2013-0381** to the Application.

The IESO is seeking the following approvals from the Board:

- Approval of its proposed 2014 revenue requirement of \$129.9 million;
- Approval of its proposed 2014 capital expenditure envelope of \$24 million for capital plans;
- Approval for the continuation of the \$1,000 application fee;
- Approval of a usage fee of \$0.803/MWh to be paid commencing January 1, 2014 by all market participants based on energy withdrawn from the IESO controlled grid, including scheduled exports and embedded generation. The IESO proposes to continue to charge the Interim Usage Fee (\$0.822/MWh) to market participants from January 1, 2014 until the end of the month in which Board approval is received for the 2014 usage fee.
- Approval to rely on and use the information provided to the IESO by electricity distributors on the amount of embedded generation in their service territory under O.Reg 429/04 in calculating the total usage fee to be billed to each electricity distributor each billing period.
- Approval of Interim Usage Fee as the final usage fee for each of the 2012 and 2013 fiscal years; and
- Approval to retain \$5 million of the accumulated surplus from the 2011, 2012 and 2013 fiscal years. The IESO proposes to rebate the balance of the accumulated surplus, based on the IESO's audited 2013 financial statements to market participants based on each market participant's proportionate quantity of energy withdrawn from the IESO controlled grid (including scheduled exports) for 2013.

The IESO is proposing to change its fee structure to also include energy volumes equal to the output from generation embedded in local distribution networks. Currently, those volumes are not included in the determination of the IESO fee as this fee is based on energy withdrawals net of embedded generation.
