Re: Service Area Amendment

**Brant Waterloo Road** 

EB-2013-0409

Cambridge and North Dumfries Hydro Inc. ("CND"), with the consent of Hydro One Networks Inc. ("Hydro One"), previously applied for a Service Area Amendment related to specifically named properties on Brant Waterloo Road (EB-2011-0018) under section 74 of the *Ontario Energy Board Act, 1998*. The application addressed the long term load transfer arrangement between CND and Hydro One, transferring twenty customers from Hydro One to CND.

The OEB issued its Decision and Order in the matter on April 25, 2011 and found that, based on the evidence provided and in the public interest, the permanent transfer of customers from Hydro One to CND should be approved as requested by the applicant. The OEB ordered that CND's electricity distribution licence (ED-2002-0574) be amended to include the customers in the County of Brant located at 542, 548, 552, 564, 568, 572, 606, 616, 642 (2 customers), 670, 674, 764 (2 customers), 790, 794, 806, 872, 896, and 900 Brant Waterloo Road. The OEB also ordered that Hydro One's electricity distribution licence (ED-2003-0043) be amended to exclude the similarly named addresses.

It has recently come to the attention of CND that the owner of the property at 794 Brant Waterloo Road has subdivided their existing property, and has created two additional severances, identified as 800 and 802 Brant Waterloo Road. Electrical service has been requested for 800 Brant Waterloo Road. Service for 802 Brant Waterloo Road has not yet been requested. The property previously described as 794 Brant Waterloo Road is now subdivided into three separate properties now described as 794, 800 and 802 Brant Waterloo Road.

As these two additional properties are not specifically named on CND's electricity distribution licence nor are they excluded from Hydro One's electricity distribution

licence, this letter requests that 800 and 802 Brant Waterloo Road be added to CND's licence and excluded from Hydro One's licence.

CND has included a drawing (Exhibit 1) provided by the County of Brant indicating the new addresses. Also attached are a current map that indicate 794 Brant Waterloo Road and specifically Lot 30 (Exhibit 2); the splitting of Lot 30 into various parts (Exhibit 3) and a similar map (Exhibit 4) that indicated the addresses that comprise the new Lot 30; 794 Brant Waterloo Road, 800 Brant Waterloo Road and 802 Brant Waterloo Road.

CND has had discussions with Hydro One regarding the two additional named properties; CND and Hydro One have jointly determined that Hydro One is not able to service these addresses. Hydro One, on December 6, 2013, submitted a Letter of Support of CND's request. A copy of the letter is attached as Exhibit 5.

Both Hydro One and CND request that this licence amendment request proceed by way of a written and not an oral hearing.







## EB-2013-0409 - Cambridge and North Dumfries Hydro Inc. Request for Licence Amendment -**Hydro One Networks' Letter of Support**

This is to confirm that Hydro One Networks Inc. ("Hydro One") supports Cambridge and North Dumfries Hydro Inc. ("CND") in the CND request, as filed on November 21, 2013 to amend, as proposed in the application, CND's Distribution Licence.
