**IN THE MATTER OF** the *Municipal Franchises Act,* R.S.O. 1990, c. M.55, as amended;

**AND IN THE MATTER OF** an application by Union Gas Limited for an order cancelling the existing Certificates of Public Convenience and Necessity for the former municipalities within the Township of South Dundas and replacing them with a single Certificate of Public Convenience and Necessity for the amalgamated Corporation of the Township of South Dundas.

### **DECISION AND ORDER**

Union Gas Limited filed an application dated June 12<sup>th</sup>, 2006 with the Ontario Energy Board under the *Municipal Franchises Act*, R.S.O. 1990, c. M.55, as amended (the "Act") for an order cancelling the existing Certificates of Public Convenience and Necessity for the former Village of Iroquois (F.B.C. 52), the former Township of Williamsburg (F.B.C. 218), the former Village of Morrisburg (F.B.C. 53), and the former Township of Matilda (F.B.C.213) (collectively the "Former Municipalities") and replacing them with a new certificate of Public Convenience and Necessity for the Corporation of the Township of South Dundas, which now incorporates all the Former Municipalities. The Board has assigned File No.EB-2006-0142 to this application.

The Board's Notice of Application and Notice of Written Hearing was published on July 5, 2006. No submissions were received.

Based on the information provided in the application, the Board finds that it is in the public interest to grant the application and that public convenience and necessity require that approval be given.

### IT IS THEREFORE ORDERED THAT:

- 1. The Certificates of Public Convenience and Necessity for the former Village of Iroquois (F.B.C. 52), the former Township of Williamsburg (F.B.C. 218), the former Village of Morrisburg (F.B.C. 53), and the former Township of Matilda (F.B.C.213), are cancelled.
- 2. A certificate of Public Convenience and Necessity, attached as Appendix A is granted to Union Gas Limited to construct works to supply gas in the Corporation of the Township of South Dundas.
